

RESOLUTION NO. 2676

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
DECLARING WEEDS AND REFUSE UPON OR IN FRONT OF
CERTAIN PARCELS OF REAL PROPERTY TO BE A
PUBLIC NUISANCE**

BE IT RESOLVED by the City Council of the City of Soledad as follows:

Section 1. It is hereby found and declared that noxious or dangerous weeds, of a seasonal and recurrent nature, are growing on, in front of, and/or behind certain parcels of real property in the City of Soledad. A particular description of said parcels is hereunto attached, marked, "Exhibit A", and by reference made a part hereof.

Section 2. It is hereby further found and declared that said weeds growing on or in front of said parcels or real property, and rubbish, refuse and dirt upon or in front of the same, constitute a seasonal and recurrent public nuisance which must be abated by the removal of said noxious or dangerous weeds, rubbish, refuse and dirt, and that otherwise they will be removed and the nuisance will be abated by the City authorities; that in the case of abatement by the City authorities the cost of such removal, together with costs incurred by the City in enforcing abatement upon the parcels, including investigation, boundary determination, measurement, clerical and other related costs, will be assessed upon the land from or in front of which the weeds, rubbish, refuse and dirt are removed; that upon confirmation such cost will constitute a lien upon such parcel or lands until paid.

Section 3. The City Council will meet and hold a public hearing on June 3rd, 1998, at the hour of 6:30 p.m., in the Council Chambers at City Hall, 248 Main Street, Soledad, California, for the purpose of hearing and considering objections to the proposed removal of weeds, rubbish, refuse and dirt from any and all of said parcels.



Dear Property Owners:

As of May 1, 1998, the above referenced property was determined to be in violation of the California Government Code, Section 39501 et seq., "Weed and Rubbish Abatement".

You are requested to remove all weeds, rubbish, refuse from your property by June 3, 1998.

If you choose not to voluntarily comply with this request, this letter shall serve as notice that on the 3th day of June, 1998, the City Council of the City of Soledad will hold a public hearing to consider adopting a Resolution declaring that, "the noxious or dangerous weeds growing and/or debris is stored upon, in front, and/or behind your parcel," a public nuisance which must be abated by the removal of the weeds, rubbish, refuse and dirt.

All property owners having any objections to the proposed removal of weeds, rubbish, refuse and dirt are hereby notified to attend the meeting of the City Council to be held on Wednesday, June 3th, at 6:30 p.m. in the City Hall Council Chambers, 248 Main Street, Soledad, California, when their objections will be heard and given due consideration.

A public hearing will be held on Wednesday, June 3th to review sites that are not in conformance with weed abatement standards. Sites found not to be in compliance will have until June 8th to comply. After June 8th, the Public Works Superintendent will be authorized to abate the nuisances and the costs charged to the property owner.

The City's Weed Abatement Program is an annual process that improves property appearance and reduces the potential for fires and damage to property. The City looks forward to working with you on any problems you may have in complying with the City Ordinances.
