

RESOLUTION NO. 1833

AMENDMENT OF CONTRACT

THIS AMENDMENT OF CONTRACT is made by and between the CITY OF SOLEDAD, a municipal corporation of the State of California, hereinafter called "CITY," and RURAL GARBAGE AND DISPOS-ALL SERVICE, a partnership composed of ANDREW PAROLA, JOHN CHIESA, EMILIO RATTO, ANTHONY PETRI and RINALDO ROSSI, hereinafter called "CONTRACTOR," as follows:

RECITALS:

A. On December 14, 1977, the parties hereto executed a Contract pursuant to the Proposal of CONTRACTOR for the collection, removal and disposal of garbage and refuse in the City of Soledad for the term of five (5) years, commencing January 1, 1978.

B. Said Contract incorporated by reference the Specifications for said work adopted by CITY.

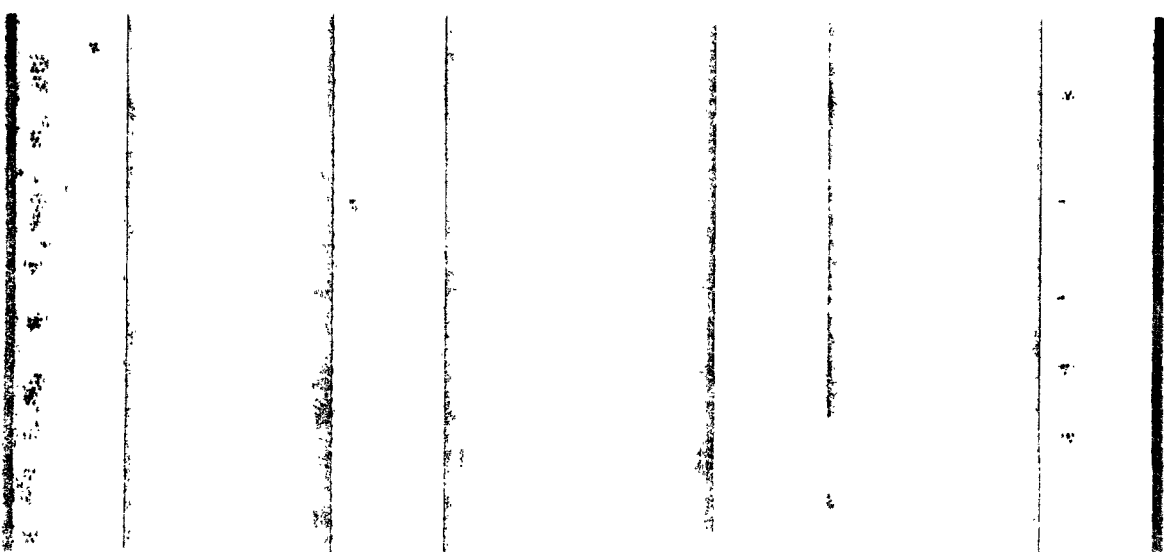
C. The said parties now desire to amend the provisions of Section 1-07 of the Specifications, as hereinbelow set forth.

AGREEMENT:

It is therefore mutually agreed by and between the said parties, as follows:

1. Section 1-07 of the Specifications referred to in Recital B above, being a part of the Contract referred to

Exhibit A



in Recital A above, is hereby amended to read as follows:

"1-07. Performance bond. At the time the contract is executed, the contractor shall furnish to City a surety bond of a surety company or companies authorized to do business in the State of California, made payable to the City of Soledad, said bond to be in the sum of Ten Thousand Dollars (\$10,000.00) and to be conditioned upon the faithful performance of said contract by the contractor during the term of the contract. The required bond will be effective only for a period of one year and will be renewable by continuation certificates for additional periods of one year, such continuation certificates to be issued at the option of the Surety. The Surety shall agree in writing to give not less than thirty (30) days' notice in writing to the City of Soledad of either cancellation or of its intent not to renew."

2. Except as hereinabove specifically amended, said Specifications of the Contract referred to in Recital A above shall remain in full force and effect, without any change or alteration whatsoever.

3. This Amendment of Contract shall be effective upon the delivery by CONTRACTOR to CITY of a fully-executed Performance Bond meeting the requirements of Section 1-07 of the Specifications, as amended by this instrument.
