

RESOLUTION NO. 1899

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AMENDING RESOLUTION NO. 1834 AND SUPPORTING THE
CONSTRUCTION OF A SOUTHBOUND HIGHWAY 101
ON-RAMP BY THE STATE OF CALIFORNIA
DEPARTMENT OF TRANSPORTATION

WHEREAS, the City of Soledad has only one Southbound Highway 101 On-Ramp to serve the Soledad community; and,

WHEREAS, the existing Southbound On-Ramp is physically separated from the City's residential tracts by a railroad right of way; and,

WHEREAS, access from the City's residential tracts to the existing on ramp can only be gained via a single railroad underpass; and,

WHEREAS, said railroad underpass is prone to closure due to flooding or vehicle accidents, thereby isolating the City's highway commercial and industrial tracts from the rest of the community; and,

WHEREAS, a closed underpass does not permit the free circulation and timely response of Soledad emergency units throughout the City; and,

WHEREAS, The City Council of the City of Soledad deems the construction of a Southbound Highway 101 On-Ramp north of the City a necessary public safety improvement for the Soledad community; and,

WHEREAS, at the request of the City Council of the City of Soledad the California Department of Transportation will consider the construction of a second Highway 101 Southbound On-Ramp.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SOLEDAD DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. That the City Council of the City of Soledad requests the construction of a Southbound Highway 101 On-Ramp north of the "North Soledad Overhead"

(5-Mon-101-62.90+) by the California Department of Transportation.

Section 2. That the City Council commits \$60,000 of the estimated \$250,000 development cost, not including the cost of right of way acquisition as the City's match for the construction of the project.

Section 3. That the City Manager is hereby authorized to represent and undertake for the City the modification of the Freeway Agreement, the preparation of a Cooperative Agreement and all other measures requisite to the implementation of the project.


Section 4. That the Mayor shall sign and the Clerk shall attest to the adoption of this Resolution.
