 RURAL GARBAGE AND DISPOS-ALL SERVICE



PASSED AND ADOPTED by the City Council of the City of Soledad at a regular meeting duly held on the 10th day of October, 1989, by the following vote:



EXTENSION OF CONTRACT

THIS EXTENSION AGREEMENT is made by and between the CITY OF SOLEDAD, a municipal corporation of the State of California, hereinafter called CITY, and RURAL GARBAGE AND DISPOS-ALL SERVICE, a partnership, hereinafter called CONTRACTOR.

RECITALS:

A. On or about December 14, 1977, the parties hereto entered into a contract whereby CITY awarded to CONTRACTOR, and CONTRACTOR accepted from CITY, the exclusive right to provide garbage and refuse collection and disposal services within the City of Soledad for the term of five (5) years, commencing January 1, 1978. Since the expiration of said term CONTRACTOR and CITY have, by mutual agreement, continued said contract in effect on a month-to-month basis and extending the contract.

B. By this agreement the parties are again extending the term of said contract, as hereinbelow provided.

AGREEMENT:

It is therefore mutually agreed by and between the said parties as follows:

1. Extension of term. The term of said contract is hereby extended for the term of five (5) years, commencing as of January 1, 1990 and ending December 31, 1994.

IN WITNESS WHEREOF, the said parties have executed this agreement this 10th day of October, 1989.
