CITY OF SOLEDAD



PASSED AND ADOPTED by the City Council of the City of Soledad at a regular meeting duly held on the 23th day of May, 1990, by the following vote:



SUBJECT LETTER OF AGREEMENT

Under provisions of the Revenue and Taxation Code, Sections 11005 6, and the Streets and Highways Code, Section 2107 2, the Department of Finance may estimate the population of any city or county upon request, if, in the opinion of the Department, there is adequate information made available upon which to base the estimates. The Department thereby agrees to complete a population estimate for the city named below as of April 1, 1990 subject to the following conditions

- 1 That the City of Soledad shall provide all data requested by the Department of Finance, so the Department can determine if adequate data are available upon which to base an estimate
- 2 That within thirty (30) days after notification by the Department of Finance of the completion of the population estimates the city agrees to reimburse the Department for all costs incurred by the Department relating to the population estimate. The Department will furnish a statement of costs, in writing, which will accompany the population estimate
- 3 That the local jurisdiction will provide a copy of the request, resolution, order, or motion of the local governing body that has the authority to authorize the Agreement
- 4 The cost of the population estimate will not exceed \$1200 00
