A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SOLEDAD COMMENDING  
AMBULANCE VOLUNTEER  
ATTENDANTS

WHEREAS, for the greater part of four decades the City of Soledad operated a Basic Life Support and Rescue Ambulance Program on the strength and commitment of a dedicated corps of Volunteer Ambulance Attendants; and,

WHEREAS, the Soledad Volunteer Ambulance Attendant Corps represents and upholds the finest traditions of volunteer public service to neighbors and community, and,

WHEREAS, without the commitment and dedication of Volunteer Ambulance Attendants, the Soledad community and the surrounding 189 square mile service area could not benefit from nor afford first class emergency medical transportation; and,

WHEREAS, the Mayor and City Council of the City of Soledad wish to honor all of the dedicated and talented volunteers who offered this community their compassion and goodwill, decades before the advent of a regionwide emergency medical transportation network.


