 OF RESTROOMS AT VOSTI PARK



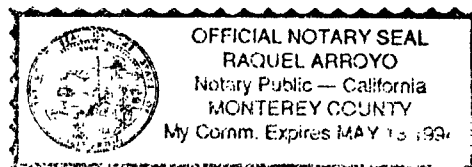
