A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
ACCEPTING A BID IN THE AMOUNT OF \$10,322.00 FROM  
HEVRIN CONSTRUCTION, INC., FOR REPAIRS TO  
CITY RESIDENCE AT 546 SOLEDAD STREET

accepted a bid for the "Repairs to City Residence at 546  
Soledad Street" and,

WHEREAS, the bid of Hevrin Construction, Inc., in the  
amount of \$10,322.00 was the lowest most responsible bid  
submitted for the Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF  
SOLEDAD DOES HEREBY RESOLVE AS FOLLOWS.

Section 1. That the bid in the amount of  
\$10,322.00 submitted by Hevrin Construction, Inc., for the  
"Repairs to City Residence at 546 Soledad Street" is hereby  
declared the lowest most responsible bid.

Section 2. That all other bids are hereby  
rejected.

Section 3. That the Interim City Manager and/or  
City Manager upon the review and consent of the City Attorney  
is hereby directed to execute a contract with Hevrin  
Construction, Inc., in the form of the document hereunto  
attached, marked, "Exhibit A," and by reference made a part  
hereof.

Section 4. That the Interim City Manager and/or  
City Manager is hereby authorized to issue a "Notice to  
Proceed" to Hevrin Construction, Inc., upon the review and  
consent of the City Attorney and Building Official that all  
contract requirements pertaining to the project have been  
fulfilled.

Remove the electric wires leading to the garage and place them underground

Replace the broken window in the garage

Interior: Remove and replace carpet with a \$20.00 per yard allowance. 5/8 inch pad

Patch cracks in walls and ceilings, strip and paint throughout. Kelly Moore "Navaho White"

Remove and replace shower door in master bath

Replace the dishwasher with \$500.00 allowance

Provide additional combustion air for furnace

Remove wallpaper and texture walls in entry

Cost: Labor and Material. . . . . \$ 10,322.00


