

RESOLUTION NO. 2097

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROVING A ZERO PROPERTY TRANSFER BY AND BETWEEN
THE COUNTY OF MONTEREY AND THE CITY OF SOLEDAD
FOR THE PROPOSED 287 ± ACRE "SOLEDAD
WASTEWATER TREATMENT PLANT
REORGANIZATION"

WHEREAS, an application requesting reorganization of the 287± acre proposed Soledad Wastewater Treatment Plant involving annexation to the City of Soledad and detachment from the Gabilan-Santa Lucia Resource Conservation District and the Mission-Soledad Rural Fire Protection District has been made to the Monterey County Local Agency Formation Commission (LAFCO) by the City of Soledad, and,

WHEREAS, Revenue and Taxation Code Section 99 requires the Board of Supervisors of Monterey County to determine an appropriate tax transfer for all jurisdictional changes of organization occurring within Monterey County and for the City Council of an affected City to concur on the tax transfer prior to the proposal being considered by the Local Agency Formation Commission (LAFCO), and,

WHEREAS, pursuant to Revenue and Taxation Code 99(b)(g), the Executive Officer of the Monterey County Local Agency Formation Commission shall not issue a Certificate of Filing (Section 56828 of the Government Code) for a change of organization until an exchange of property tax revenues is negotiated, and,

WHEREAS, said territory will be owned by the City of Soledad and is exempt from local property taxes.

NOW, THEREFORE, the City Council of the City of Soledad DOES HEREBY RESOLVE, DETERMINE and ORDER as follows:

Section 1. THAT THE CITY COUNCIL OF THE CITY OF SOLEDAD DOES HEREBY RESOLVE, APPROVE AND ACCEPT, a zero tax transfer by and between the County of Monterey and the City of Soledad for the proposed "Soledad Wastewater Treatment Plant Reorganization", 287 ± acres.

Section 2. That the City Clerk of the City of Soledad is hereby authorized and directed to file a certified copy of this resolution with the Executive Officer of the Local Agency Formation Commission of the County of Monterey.
