

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
CONFIRMING REPORT OF COSTS OF WEED ABATEMENT AND
PROVIDING FOR THE COLLECTION THEREOF WITH
MUNICIPAL TAXES (GOVERNMENT CODE
SECTIONS 39560-39588)

BE IT RESOLVED by the City Council of the City of Soledad, as follows:

THAT WHEREAS the City Council adopted Resolution No. 2085 on May 22nd, 1991, declaring weeds upon or in front of certain parcels of real property in the City of Soledad, therein particularly described, to be a seasonal and recurrent public nuisance; and,

WHEREAS, on May 22nd, 1991, after giving notice as required by law, the City Council held a public hearing to hear and consider all objections to the proposed removal of said weeds; and,

WHEREAS, no objection to the proposed removal of weeds from said parcels of land was made or presented at said hearing and the City Council thereupon, by motion duly passed at the conclusion of the hearing, ordered that the work of removal be performed by the Superintendent of Streets in accordance with the provisions of Section 39571 of the Government Code; and,

WHEREAS, the Superintendent of Streets has performed said work of removal as ordered by the City Council; and,

WHEREAS, the Superintendent of Streets has kept an account of the cost of such weed abatement on each of said parcels, including costs incurred by the City of Soledad in enforcing abatement upon each of said parcels as provided in Section 39577 of the Government Code, and has presented his report of such cost to the City Council for confirmation, a copy of which is hereunto attached, marked "Exhibit A," and incorporated herein by reference; and,

WHEREAS, a copy of said report and a notice of hearing on the same were duly posted for the time and in the manner specified in Section 39575 of the Government code; and,

WHEREAS, the City Council has this date held a public hearing upon said report for the purpose of receiving and considering the same and hearing any objections thereto; and,

WHEREAS, no objection to said report was made or presented to the City Council,

IT IS THEREFORE FOUND, ORDERED AND DETERMINED AS FOLLOWS.


1. That all of the statements contained in the foregoing recitals of this resolution are true and correct.
2. That the report of cost of abatement filed by the Superintendent of Streets ("Exhibit A") hereto is correct and the same is hereby confirmed.
3. That the cost of abatement on each parcel of land, as set forth in said report ("Exhibit A") hereto, constitutes a special assessment against that parcel and is a lien on said parcel.
4. That the City Clerk is hereby directed to record a certified copy of this resolution and of said report ("Exhibit A") hereto in the office of the County Recorder of Monterey County, and to transmit certified copies of this resolution and said report to the County Assessor, the County Auditor, and the County Tax Collector of Monterey County or or before August 10, 1991; the County Assessor and the County Tax Collector are hereby notified that the amount of the assessment against each parcel described in said report is to be added to the next regular tax bill levied against said parcel for municipal purposes, as provided in Section 39578 of the Government Code.
