AMENDMENT NUMBER ONE TO THE AGREEMENT BETWEEN THE CITY  
OF SOLEDAD AND PENINSULA PARAMEDIC SERVICES, INC  
FOR THE FURNISHING OF EMERGENCY AMBULANCE  
SERVICE EXCLUSIVELY IN THE  
SOLEDAD AREA

THIS AGREEMENT has been made and entered into this 25th day of November, 1991, by and between the City of Soledad, hereinafter called "CITY" and Peninsula Paramedic Services, Inc , hereinafter called "CONTRACTOR"

IT IS HEREBY AGREED AS FOLLOWS

WHEREAS, the parties have heretofore on November 28, 1990, entered into an AGREEMENT for providing ambulance services, a copy of which is attached hereto as "Exhibit A", and

WHEREAS, the City desires to extend the AGREEMENT for a twelve month period, and automatically renew the contract thereafter for three consecutive twelve-month periods, for a total of forty-eight (48) months as agreed below, and

WHEREAS, certain language in the existing contract needs clarification to be consistent with actual practices under the contract.

IT IS HEREBY AGREED AS FOLLOWS

The Ambulance Service AGREEMENT is extended for a period of January 1, 1992, to January 1, 1993 and shall automatically renew without further action for the periods, January 1, 1993 to January 1, 1994, and January 1, 1994 to January 1, 1995, and January 1, 1995, to January 1, 1996, depending on the availability of funds.

The following clarifications of the contract shall become a part of the contract.

Section 6 Subsection (c) add the following sentence:

"It is understood this is a minimum level of service and nothing prevents PenMed from increasing the level of service to the Soledad coverage area."

Section 20 Subsection (a) amended as follows:

"This Agreement may be terminated unilaterally by PenMed for reasons related to emergency ambulance patient care Said termination shall be effective one hundred eighty (180) days after the date of such notice to City."
