

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
CONCERNING INTENT TO VACATE AN ALLEY PURSUANT TO
STREET AND HIGHWAYS CODE PART 3, CHAPTER 3,
SECTION 8320 AND FOLLOWING

WHEREAS, Streets and Highways Code Section 8320
requires that the Council shall, by resolution, advise of its
intention to vacate an alley described as follows:

That certain alley extending north from Palm Avenue in
the City of Soledad for approximately 135 feet as
shown on Assessor's Maps of Soledad on file in the
office of the City Clerk, City of Soledad, 248 Main
Street, Soledad, California 93960, reserving to the
City of Soledad any and all utility easements located
therein and thereon.

WHEREAS, pursuant to Government Code Section 65402,
the City Planning Commission has recommended to the Council its
finding that the vacation of a portion of the alley is in
conformance with the General Plan; and

WHEREAS, pursuant to Streets and Highways Code Section
2381, the Planning Commission has recommended to the Council its
finding that this portion of the alley is not suitable or useful
as a non-motorized transportation facility; and


WHEREAS, the vacation of this portion of the alley
will not affect any in-place, in-use public utility facilities
or that adequate relocation of utilities is provided.

NOW, THEREFORE, the City Council of the City of
Soledad resolves as follows

- 1 The City Council shall hold a public hearing on
February 10, 1992, at 6:30 p.m., to consider a
Resolution of Vacation at which time all persons
interested in the proposed vacation may be heard.
2. The City Clerk shall cause the notice of this public
hearing to vacate this portion of the alley right of
way to be published in the same manner as other
resolutions of this Council.
3. The City Clerk shall execute and file an affidavit, as
proof of publication of the notice of public hearing
to vacate.
4. The City Clerk shall forthwith cause to be posted,
conspicuous notices of vacation in compliance with
Streets and Highways Code Section 8323. As proof of
the posting of the notice, the Clerk shall execute and
file an affidavit setting forth and file an affidavit
setting forth the facts of the posting in detail, as
to time and manner.

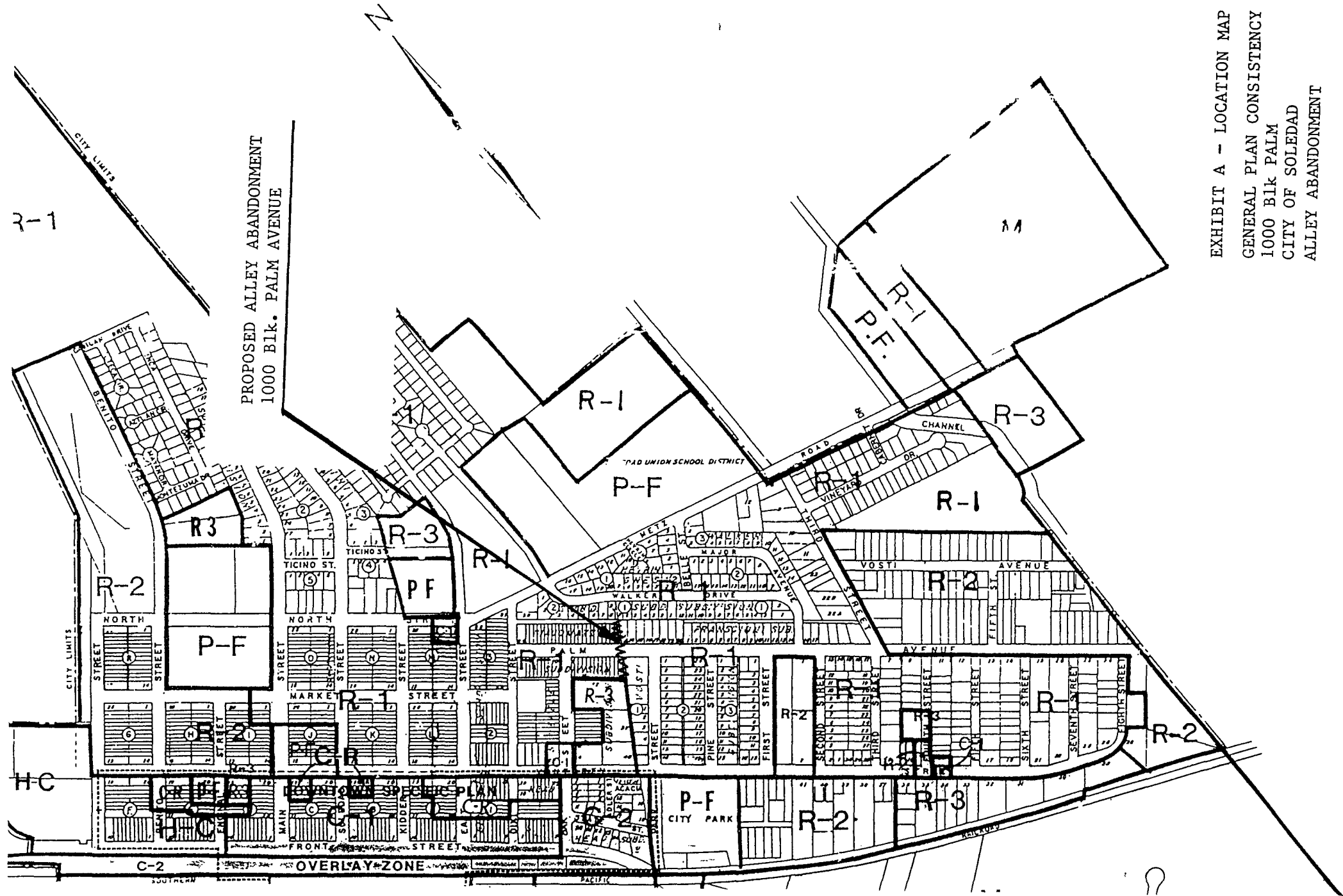
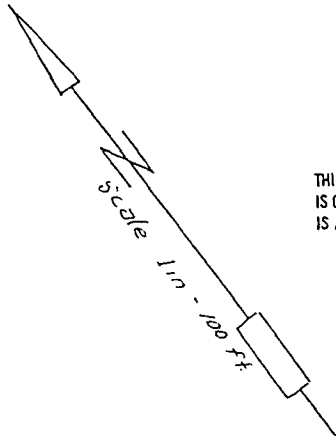


EXHIBIT A - LOCATION MAP

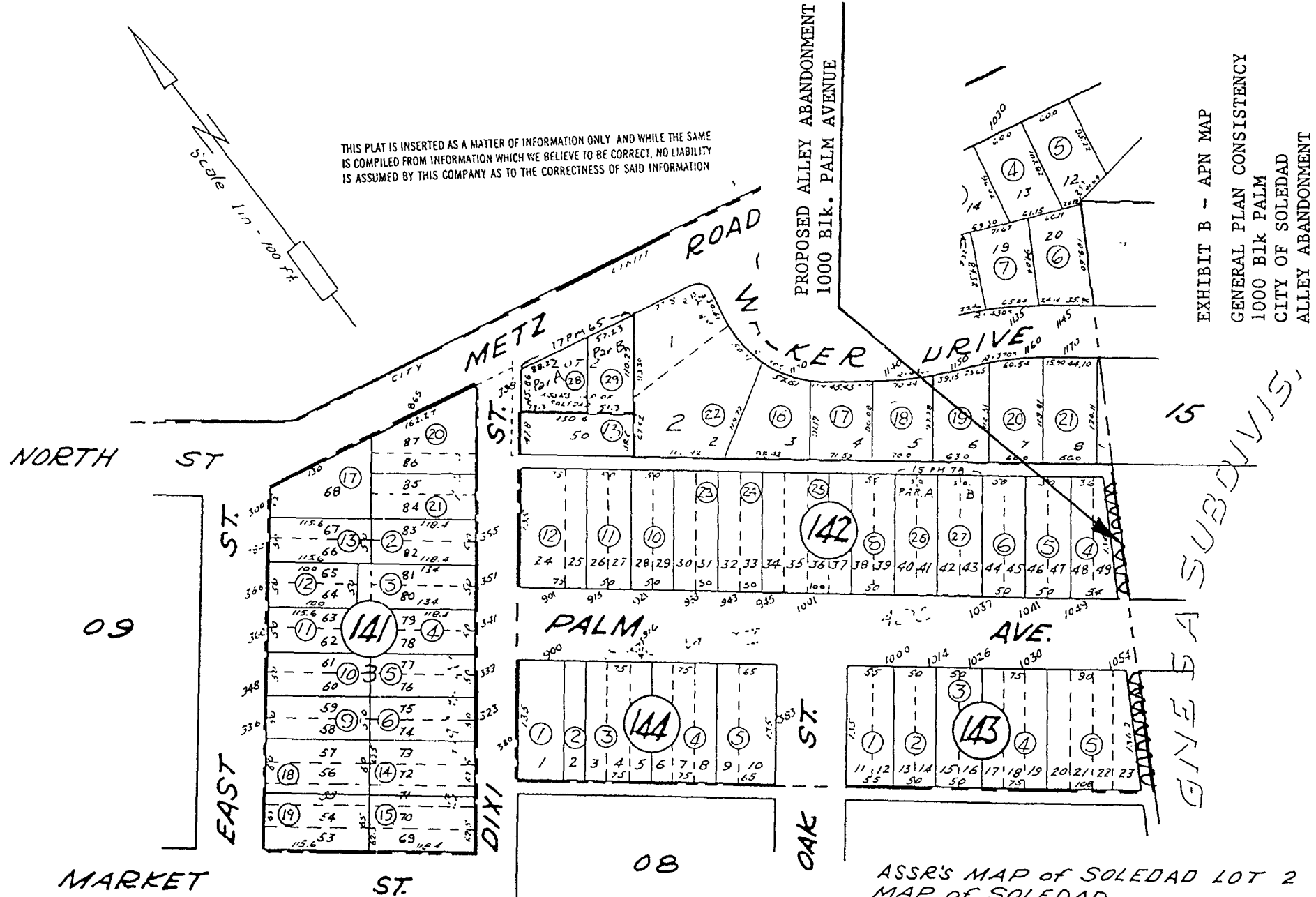


EXHIBIT B - APN MAP

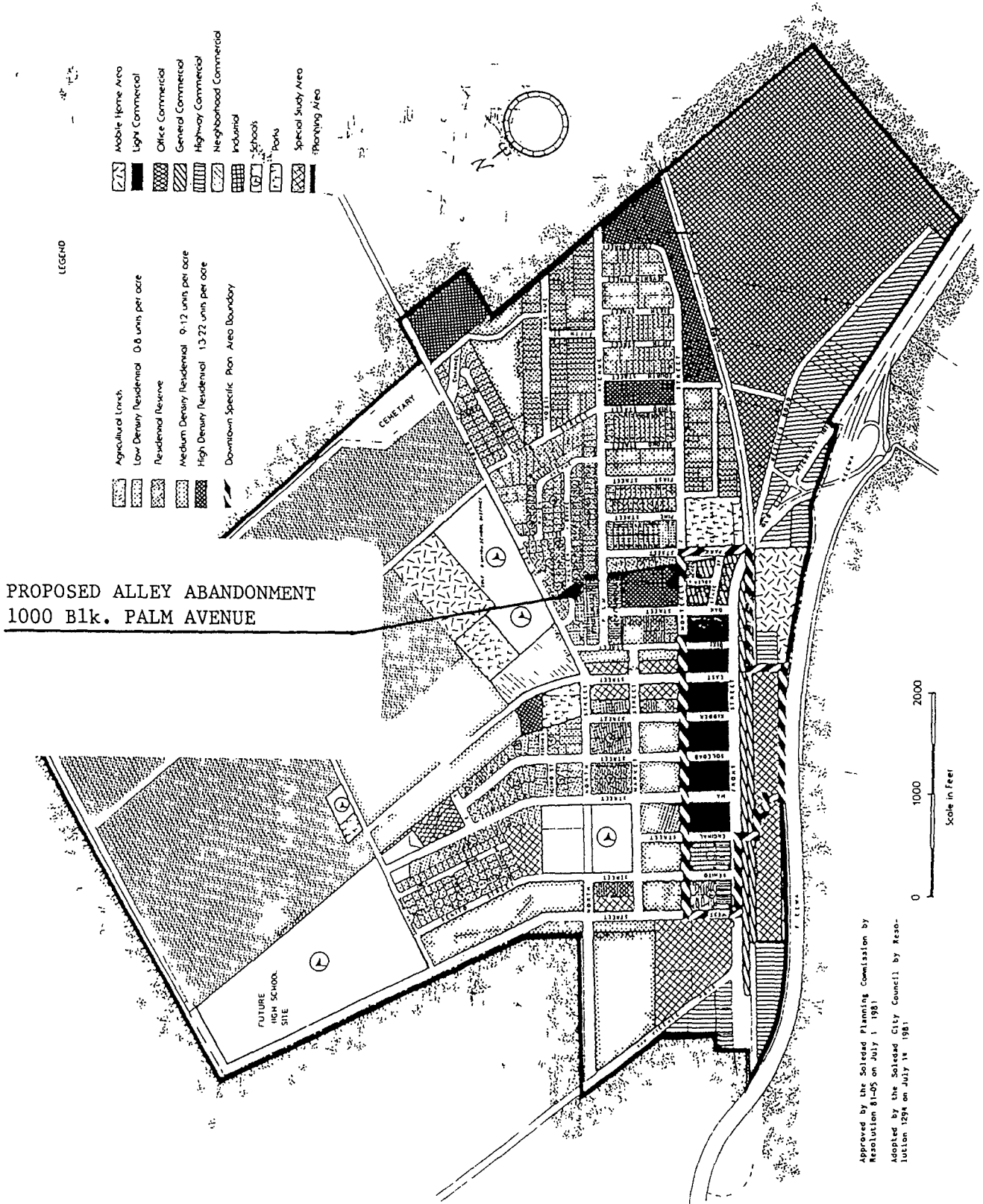
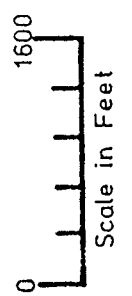
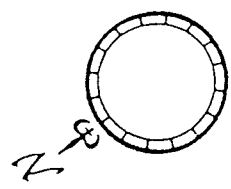
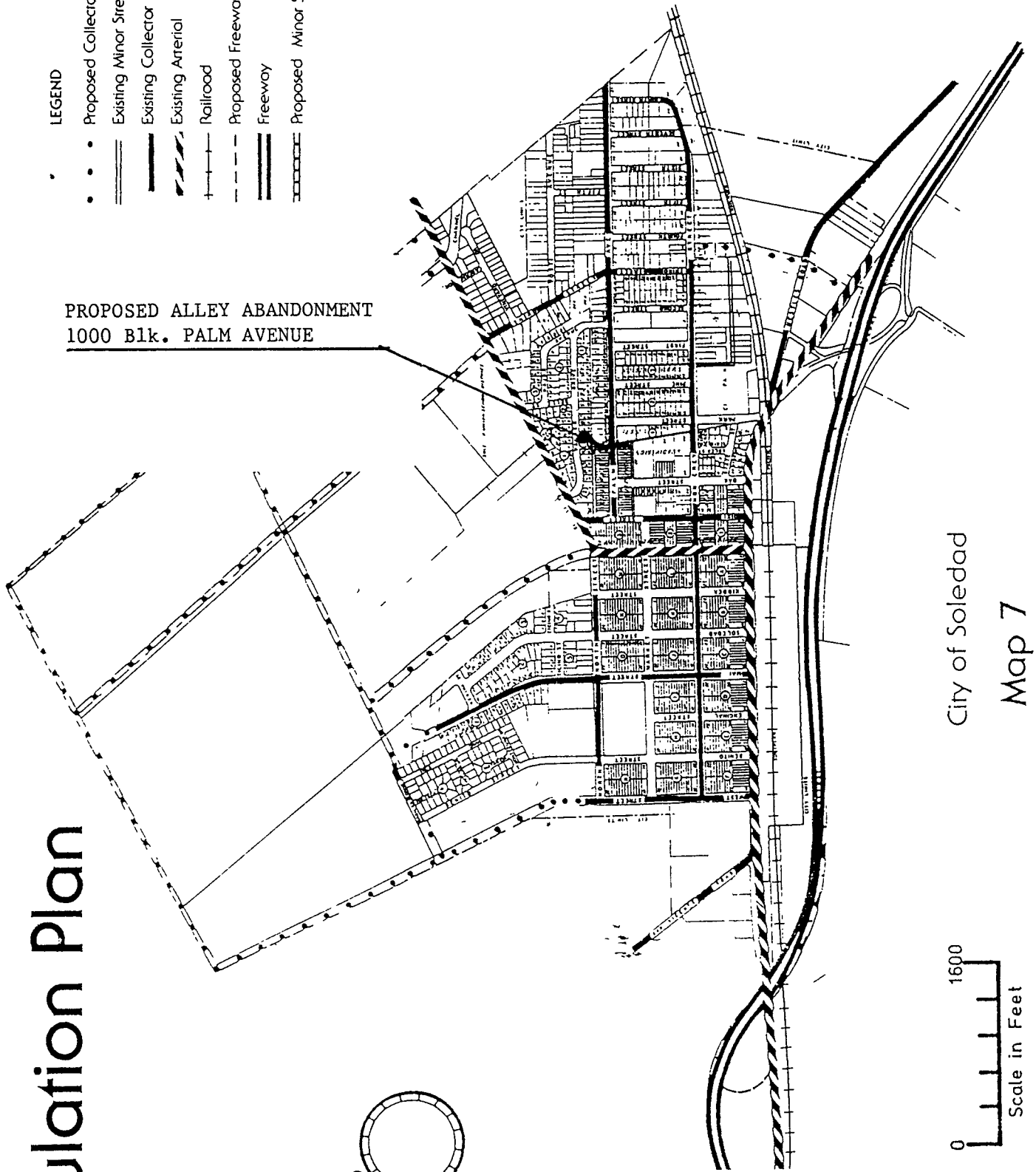


EXHIBIT C - GENERAL PLAN MAP
