

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
VACATING AN ALLEY EXTENDING NORTH FROM
PALM AVENUE IN THE CITY OF
SOLEDAD

BE IT RESOLVED by the City Council of the City of Soledad as follows:

Section 1: These proceedings for the vacation of an alley in the City of Soledad, Monterey County, California, are taken pursuant to the provisions of Chapter 3, Part 3, Division 9 (commencing with Section 8320) of the Streets and Highways Code of the State of California. The alley to be vacated is described as follows:

That certain alley extending north from Palm Avenue in the City of Soledad for approximately 135 feet as shown on Assessor's Maps of Soledad on file in the office of the City Clerk, City of Soledad, 248 Main Street, Soledad, California 93960, reserving to the City of Soledad any and all utility easements located therein and thereon.

Section 2: Pursuant to Section 8324 of the Streets and Highways Code, the City Council hereby finds and determines, from all the evidence submitted at a hearing held on this date, that the alley hereinbefore described is unnecessary for present or prospective public use.

Section 3: At its regular meeting held on January 15, 1992, the Planning Commission considered the proposed vacation pursuant to the provisions of Section 65402 of the Government Code, and found that said vacation did not conflict with the City of Soledad General Plan; it thereupon made its written report and recommendation to the City Council that said alley be formally vacated by the City.

Section 4: Pursuant to the provisions of Section 8340 of the Streets and Highways Code, there is hereby reserved unto the City, and expected from this alley vacation, the easement and right at any time, or from time to time, to construct, maintain, operate, replace, remove and renew sanitary sewers and storm drains and appurtenant structures in, upon, over and across the portion of said alley to be vacated, and to construct, maintain, operate, replace, remove and renew lines of pipe for the distribution of water in, upon, over and across said alley.

Section 5: Subject to the reservations contained

in Section 4, IT IS HEREBY ORDERED that said portion of alley as particularly described in Section 1 hereof, be, and the same is hereby, vacated.
