

## RESOLUTION NO. 2143

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
 APPROVING THE ISSUANCE OF SOLEDAD REDEVELOPMENT  
 AGENCY, SOLEDAD REDEVELOPMENT PROJECT, 1992  
 TAX ALLOCATION REFUNDING BONDS AND  
 APPROVING, AUTHORIZING AND  
 DIRECTING EXECUTION OF  
 INDENTURE OF TRUST AND  
 OFFICIAL STATEMENT

WHEREAS, the Soledad Redevelopment Agency (the "Agency") proposes to issue its Soledad Redevelopment Project, 1992 Tax Allocation Refunding Bonds in an aggregate principal amount of not to exceed \$5,250,000 (the "Bonds") for the purpose of refunding the Agency's \$1,200,000 Soledad Redevelopment Project, Tax Allocation Bonds, Issue of 1985 and to finance additional redevelopment activities within or of benefit to the Project Area.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF SOLEDAD, CALIFORNIA, that the issuance of the Bonds by the Agency and the entering into of the Indenture of the Trust on the terms and conditions described in the Agency action relative thereto of even date herewith are hereby approved.
