A RESOLUTION OF CITY COUNCIL OF THE CITY OF SOLEDAD
ESTABLISHING A BAIL SCHEDULE FOR SPECIFIC
VIOLATIONS OF CITY CODE AS PER STATE
OF CALIFORNIA PENAL CODE
SECTION 1269B

BE IT HEREBY RESOLVED by the City Council of the City of Soledad that the following document entitled, "Bail Schedule for Specific Violations of City Code", dated the 13th day of July, 1992, is approved and adopted by reference in the form of the document hereunto attached marked, "Exhibit A".

WHEREAS, the Monterey County Judicial System requires the City to adopt by resolution a bail schedule for misdemeanor and infraction violations of City Code.


WHEREAS, the City's bail schedule was amended prior to 1989.
