

RESOLUTION NO. 2190

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
 DETERMINING THE AMOUNT OF REVENUE NECESSARY
 IN FISCAL YEAR 1992/1993 TO PAY BONDED
 INDEBTEDNESS AND FIXING THE RATE OF
 TAXES TO BE LEVIED FOR THAT
 PURPOSE

BE IT RESOLVED by the City Council of the City of
 Soledad as follows:

Section 1. That it is hereby found and determined
 that the amount of money necessary to be raised from
 property taxes in Fiscal Year 1992/1993 to meet the
 bonded indebtedness of the City is the sum of \$10,500.

Section 2. That for Fiscal Year 1992/1993 the
 City Council does hereby fix the rate upon taxable
 property in the City for bonded indebtedness at .0144
 for every One Hundred Dollars (\$100) of full assessed
 valuation.

Section 3. Tax Rate Areas 6015 and 6016 are
 hereby exempted from the tax levy imposed by this
 Resolution.

Section 4. That the Clerk shall transmit
 certified copies of this Resolution to the Assessor
 and Auditor-Tax Collector of the County of Monterey,
 and the Controller of the State of California.
