 STREETS PROJECT





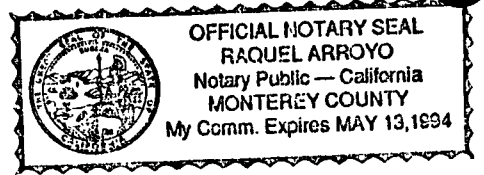
