

**RESOLUTION NO 2321****A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
ACCEPTING A BID IN THE AMOUNT OF \$132,946 FROM  
GRANITE CONSTRUCTION COMPANY TO FURNISH AND  
INSTALL A FOUR INCH DIAMETER SEWER FORCE  
MAIN AND WASTEWATER PUMP STATION  
AT CAMPHORA-GLORIA ROAD**

**WHEREAS**, the City of Soledad has been granted a Community Development Block Grant in the amount of \$477,000 and these funds will be used to install a pump station and a force main between the Dole Fresh Vegetable Salad Plant and the City Wastewater Treatment Plant; and

**WHEREAS**, Dole Fresh Vegetables has entered into a First Source Hiring Agreement with the City wherein Soledad residents will have the first opportunity to be considered for all new hiring; and

**WHEREAS**, Dole Fresh Vegetables has agreed to pay the City for all costs it may incur as a result of its efforts to obtain necessary approvals and have the four inch force main and pump station installed, to the extent such costs are not paid by the Community Development Block Grant; and

**WHEREAS**, the City has awarded a contract in the amount of \$51,057 for the installation of the segment of the four inch force main between the City Wastewater Treatment Plant and a point west of the railroad right-of-way just south of Camphora-Gloria Road; and

**WHEREAS**, installation of the segment of the four inch force main between the City Wastewater Treatment Plant and Camphora-Gloria Road is nearly completed; and

**WHEREAS**, the remaining segment of the four inch force main between the City Wastewater Treatment Plant and the Dole Plant is that portion that runs from Camphora-Gloria Road to the Dole Plant; and

**WHEREAS**, the bid from Granite Construction Company in the amount of \$132,946, was the lowest most responsible bid submitted for the project.

**NOW, THEREFORE**, the City Council of the City of Soledad does ordain as follows:

**Section 1.** That the bid in the amount of One Hundred Thirty-Two Thousand Nine Hundred Forty-Six Dollars (\$132,946) submitted by Granite Construction Company is hereby declared the lowest most responsible bid.

**Section 2.** That the Interim City Manager is hereby directed to execute a contract in a form approved by the City Attorney with Granite Construction Company for the subject project.

**Section 3.** That the bid process, as followed, met requirements stipulated for projects funded by Community Development Block Grant funding.

**Section 4.** That the City Manager and/or his agents is hereby authorized to issue a "Notice to Proceed" to Granite Construction Company, subsequent to review and approval by the City Attorney of all documents pertinent to the award of the contract.
