

RESOLUTION NO. 2395

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
AUTHORIZING THE ESTABLISHMENT OF FEES AND CHARGES  
FOR ANIMAL SHELTER, IMPOUNDMENT, DISPOSITION,  
AND LICENSING SERVICES

WHEREAS, Soledad Municipal Code Section 6.24.030 provides that the City Council shall by resolution establish, and may from time to time amend, a schedule of fees and charges for the provision of animal services within the City, including, but not limited to, shelter, impoundment, disposition, and licensing of animals; and,

WHEREAS, the City of Soledad has historically contracted with Dr. Susan Parry, D.V.M., who operates the Los Coches Animal Hospital, for animal shelter, impoundment, disposition, and licensing services; and,

WHEREAS, Dr. Parry has provided the City with an estimate of costs for such services for Fiscal Year 1994/1995, which includes but is not limited to \$55 for every animal impounded and euthanized, and \$40 for animals that are impounded and then subsequently adopted by a new owner.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Soledad, that:

- 1. The City Council hereby adopts the fee schedule attached hereto as Exhibit "A" for the provision of animal shelter, impoundment, disposition, and licensing services within the City of Soledad.

EXHIBIT "A"**FEEES AND CHARGES FOR ANIMAL SHELTER,  
IMPOUNDMENT, DISPOSITION AND LICENSING SERVICES**

- Dogs (all sizes) \$45.00 (holding period, euthanasia, disposal)
- Cats \$40 00 (holding period, euthanasia, disposal)
- Litters \$55.00
- No fee to the City for animals subsequently adopted to new owners or returned to owners.
- Euthanasia on arrival + disposal - dog or cat - \$24.00  
- litters - \$40.00
- Disposal only \$ 7.00
- Office visits \$20.35
- Office visits (after hours) \$46.75
- Injections (antibiotics, pain killers, sedatives) \$ 8 80
- Removal of brain for Rabies evaluation \$27.50
- Rabies vaccination \$ 6 60
