

RESOLUTION NO. 3651

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AMENDING TEMPORARY USE PERMIT 2005-11 AND AUTHORIZING THE
CLOSURE OF A PORTION OF MONTEREY STREET BETWEEN THE
SOLEDAD FIRE STATION AND THE NORTHERN EDGE OF OUR LADY OF
SOLITUDE CHURCH, AND MAIN STREET FROM THE WESTERN EDGE OF THE
AMERICAN LEGION HALL TO MARKET STREET FOR OUR LADY OF SOLITUDE
ANNUAL FIESTA**

WHEREAS, on July 20, 2005, the City Council approved Temporary Use Permit 2005-11 to Our Lady of Solitude Church to allow closure of a portion of Main Street, and use of a portion of City property (the lawn area at main Street and Monterey Street and the City Hall Parking Lot), in order for the Church to conduct its annual Fiesta, and

WHEREAS, the City subsequently received a request from the Church to expand the closure of public streets to include closure of Monterey Street from the Fire Station to the Northern edge of Our Lady of Solitude Church, and Main Street, from the Western edge of the American Legion to Market Street, with the continued use of City property adjacent to or in close proximity to Main Street, on August 14, 2005 from 10 AM to 7 PM, and

WHEREAS, Our Lady of Solitude has conducted similar annual Fiestas in a manner and location as described herein, with approval of the City of Soledad, and

WHEREAS, the closure of the identified streets will not cause a hardship to the local neighborhood and residents, and will be monitored by City of Soledad Police Officers throughout the day; and

WHEREAS, the event organizers will be responsible for set-up and clean-up of the public areas used, will provide the City with appropriate insurance certificates, will pay for police services required by the expanded Fiesta plan and activities, will seek consent to the event from adjacent property owners and/or tenants, and will be responsible for any necessary repairs if damage is done to City property

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the City Council of the City of Soledad that the City Council hereby approves amendment of Temporary Use Permit 2005-11 to allow the closure of Main Street, between Monterey and Market Streets, and the use of City property, all as shown on the Map attached hereto as Exhibit "A," as an accommodation to the 2005 Annual Fiesta of Our Lady of Solitude to be held on Sunday, August 14, 2005, subject to Special and Standard Conditions of Approval for a Temporary Use, including, but not limited to those conditions referenced in the recitals set forth above.
