

**RESOLUTION NO. 3685**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
AUTHORIZING THE CLOSURE OF FRONT STREET TO VEHICULAR TRAFFIC  
BETWEEN MAIN AND ENCINAL STREETS FROM 10 AM TO 4PM ON SUNDAY,  
OCTOBER 16, 2005 FOR THE HURRICANE KATRINA DISASTER RELIEF  
COMMUNITY FUNDRAISER, APPROVAL OF THE USE OF THE CITY'S PARK AND  
RIDE LOT AND WAIVING THE ASSOCIATED FEE OF \$250, AND APPROVAL OF  
THE CITY'S DONATION OF \$5,000 TO THE RELIEF EFFORTS.**

**WHEREAS**, the City has received a request from the Soledad Lions Club for closure of Front Street, between Main and Encinal Streets, and the use of the City Park and Ride Lot, on October 16, 2005 from 10 AM to 4 PM, and

**WHEREAS**, the Lions Club, along with various community organizations, volunteers from the community and the Mission District are conducting a fundraiser for the Hurricane Katrina victims to be held within the City of Soledad, and

**WHEREAS**, the closure of the street will not cause a hardship to the local businesses and residents, and will be monitored by City of Soledad Police Officers throughout the day; and

**WHEREAS**, the event organizers will be responsible for set-up and clean-up of the public areas used and will provide the City with appropriate insurance certificates, and

**WHEREAS**, the Lions Club has requested use of the City' Park and Ride lot and waiver of the associated fee; and

**WHEREAS**, the City wishes to make a donation to the American Red Cross and the Salvation Army in the amount of \$2,500 each to help the victims of Hurricane Katrina, and

**WHEREAS**, the City has identified a source for the donation as being from the Police Department's salary line item.

**NOW, THEREFORE, BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad that the City Council approves a \$5,000 donation to be evenly divided between the American Red Cross and the Salvation Army, and the closure of Front Street as shown on the Map attached hereto as Exhibit "A," for the community fundraiser event to be held on Sunday, October 16, 2005, subject to Standard Conditions of Approval for a Temporary Use Permit. The City Council also approves the waiver of the fee and use of City Park and Ride Lot as an in-kind contribution for this event. In addition, prior to set up of the event, the Lions Club shall be required to provide an insurance policy in a form acceptable to the City, naming the City, its elected and appointed officials, employees and agents as additional insureds.
