

RESOLUTION NO. 4573

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD AWARDING THE BID TO CHEM QUIP, INC. FOR THE PURCHASE OF BULK SODIUM HYPOCHLORITE SOLUTION FOR THE WATER QUALITY DIVISION AND AUTHORIZING THE CITY MANAGER TO EXECUTE A BLANKET PURCHASE ORDER FOR AN AMOUNT NOT TO EXCEED \$45,000.00.

WHEREAS, the City of Soledad solicited bids for the purchase of sodium hypochlorite solution (bleach) required for the water and wastewater treatment system; and

WHEREAS, the water system uses approximately 3,000 gallons of sodium hypochlorite solution per year and the wastewater system uses approximately 20,000 gallons per year; and

WHEREAS, the City advertised for bids for the purchase and delivery of sodium hypochlorite solution on August 1, 2010 via web-site; and

WHEREAS, on September 21, 2010, the City received one bid from Chem Quip, Inc. a supplier for sodium hypochlorite solution; and

WHEREAS, Staff has reviewed the bid and recommends that the City Council awards the bid for the purchase of sodium hypochlorite to Chem Quip, Inc. with an option to extend contract for two additional one year terms; and

WHEREAS, expenditures for the purchase and delivery of the sodium hypochlorite solution for the water system will be expended from Water Operating budget, Chemical line item #309-5810-2032 with an adopted budget of \$15,000.; and

WHEREAS, the sodium hypochlorite solution for the wastewater system will be expended from the Wastewater Operating budget, Chemical line item #310-5910-2032 with an adopted budget amount of \$150,000 for fiscal year 2010-2011; and

NOW THEREFORE, BE IT HEREBY RESOLVED, by the City Council of the City of Soledad that the Council hereby awards the bid for the purchase of bulk sodium hypochlorite solution and authorizes the City Manager to execute a blanket purchase order with Chem Quip, Inc. for an amount not to exceed \$45,000.




