

**RESOLUTION NO. 4575**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD AWARDING THE BID TO NTU TECHNOLOGIES, INC. FOR THE PURCHASE OF POLYALUMINUM CHLORIDE COAGULANT FOR THE WATER QUALITY DIVISION AND AUTHORIZING THE CITY MANAGER TO EXECUTE A BLANKET PURCHASE ORDER FOR AN AMOUNT NOT TO EXCEED \$47,600.00**

**WHEREAS**, the City of Soledad solicited bids for the purchase of polyaluminum chloride coagulant required for the wastewater treatment system; and

**WHEREAS**, Currently, approximately 3.0 MGD of secondary effluent is processed seven (7) days a week containing 2.5 -15mg/L suspended solids; and

**WHEREAS**, the City advertised for bids for the purchase and delivery of polyaluminum chloride coagulant on August 1, 2010 via web-site; and

**WHEREAS**, on September 21, 2010, the City received three bids from Jenfitch LLC, NTU Technologies, Inc., and California Environmental Dewatering all suppliers for polyaluminum chloride coagulant; and

**WHEREAS**, Staff has reviewed the bids and all polyaluminum chloride products met turbidity specifications. Over a 24-hour period, NTU Technologies Propac 9500 provided effective turbidity removal along with the lowest price per pound; and

**WHEREAS**, expenditures for the purchase and delivery of the polyaluminum chloride coagulant for the wastewater system will be expended from the Wastewater Operating budget, Chemical line item #310-5910-2032 with an adopted budget amount of \$150,000.00 for fiscal year 2010-2011.

**NOW THEREFORE, BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad that the Council hereby awards the bid for the purchase of polyaluminum chloride coagulant and authorizes the City Manager to execute a blanket purchase order with NTU Technologies, Inc. for an amount not to exceed \$47,600.00.




