

**RESOLUTION NO. 4579**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING THE SUN STREET CENTERS' REQUEST FOR USE OF THE SOLEDAD  
COMMUNITY CENTER EVERY FOUR MONTHS FOR THEIR SOUTH COUNTY  
PREVENTION COALITION MEETINGS IN SOLEDD COMMENCING DECEMBER  
2010 THROUGH DECEMBER 2011 AND AUTHORIZING SPONSORSHIP OF THEIR  
REQUESTED USE**

**WHEREAS**, the YMCA's Management Agreement states that the City of Soledad has unlimited use of the facility for City and City sponsored events and up to fifty (50) hours for Non-City sponsored events; and

**WHEREAS**, the Sun Street Centers P.A.R.T.S (Preventing Alcohol Related Trauma in South County) Prevention Coalition has requested the use of the Soledad Community Center for their South County Prevention Coalition meetings in Soledad; and

**WHEREAS**, the Sun Street Centers has requested that the City sponsor its South County Prevention Coalition Meetings to be held at the Soledad Community Center for approximately three (3) hours per meeting, every four (4) months commencing December 2010 through December 2011; and

**WHEREAS**, the Sun Street Centers partnership with the Soledad Union School District through the SOAR (Soledad Organizing for Alcohol Reduction) grant provides Life-Skills training to parents and students, a substance abuse prevention program proven to be effective in reducing drug and alcohol use by targeting social and psychological factors associated with substance abuse and high risks behaviors; and

**WHEREAS**, the Sun Street Centers is a member of the Cal-Grip Initiative, partnering with the City of Soledad providing support services to the Soledad Police Department utilizing their STEPS (Safe Teens Empowerment Project in South County) members; and

**WHEREAS**, the Council believes that sponsorship and use of the Community Center for the Sun Street Centers' Prevention Coalition meetings will benefit the community, businesses and organizations by providing information, referral, education, prevention and recovery services to persons, agencies, organizations and businesses affected by alcohol and other drugs.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** that the City Council of the City of Soledad does hereby approve Sun Street Centers' request for use of the Soledad Community Center for their South County Prevention Coalition meetings in Soledad commencing December 2010 through December 2011 and Authorizes Sponsorship of their requested use.
