

**RESOLUTION NO. 3936**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
AUTHORIZING THE CITY MANAGER TO PURCHASE TRASH RECEPTACLES  
FROM ROSS RECREATION INCORPORATED IN AN AMOUNT NOT TO EXCEED  
\$32,101.81**

**WHEREAS**, the City Council of the City of Soledad included funding for the purchase and placement of the additional trash cans at various locations in the downtown areas and to supplement the trash cans in various parks throughout the community in the Fiscal Year 2006-2007 adopted budget in an amount of \$42,878; and

**WHEREAS**, the City advertised for bids to furnish and install the trash cans and no bid was received; and

**WHEREAS**, the City wishes to match the new trash cans with the existing trash cans to maintain the architectural and design of the existing downtown; and

**WHEREAS**, Staff has identified only one vendor that sells trash cans which match design and color of the trash cans which already exist downtown; and

**WHEREAS**, Section 3.24.040 (A) of the Soledad Municipal Code, entitled "Bidding required- Exceptions," provides "the City can forgo its usual bidding procedures when the commodity, product or equipment can be obtained from only one vendor"; and

**WHEREAS**, Staff is recommending that the Council authorize the City Manager to purchase the additional trash cans needed at various locations in the downtown areas in an amount not to exceed \$32,101.81; and

**WHEREAS**, the City allocated \$42,878 in the Fiscal Year 2006-2007, JPA Garbage Fund account number 16-71-2030, for the purchase and placement of the additional trash cans needed at various locations in the downtown areas and to supplement the trash cans in various parks throughout the community.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** the City Council of the City of Soledad that the City Manager and/or her designees is hereby authorized and directed to the purchase the additional trash cans needed at various locations in the downtown areas in an amount not to exceed \$32,101.81 pursuant to the bidding exception set forth in Soledad Municipal Code Section 3.24.040 (A).




