

**RESOLUTION NO. 3945**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
ACCEPTING THE WELL #11 PUMP STATION PROJECT COMPLETED BY  
MONTEREY PENINSULA ENGINEERING, INC. AUTHORIZING THE RELEASE OF  
THE LABOR AND PERFORMANCE BONDS AND 10% RETENTION IN THE  
AMOUNT OF \$39,618.60 AND APPROPRIATING \$39,618.60 FROM THE WATER  
FUND WELL CONSTRUCTION LINE ITEM**

**WHEREAS**, on November 2, 2005 the City Council awarded the bid for the Well No. 11 Pump Station Project, authorizing the City Manager to enter into a contract with Monterey Peninsula Engineering, Inc. for a cost not to exceed \$388,250; and

**WHEREAS**, the total allocated funding for the project is \$489,000 and the final completion project construction costs totaled \$396,186 which was less than the amount allotted for the completion project construction; and

**WHEREAS**, all of the construction engineering components of the project, such as field design changes, project management after notice to proceed through completion of project manager acceptance letter, site inspections, inspection documentation, material verification of both quality and quantity, quality assurance, any requisite contract change orders during construction, final inspection punch list, final inspection and engineer acceptance letter have been submitted to and reviewed by the Public Works Director; and

**WHEREAS**, the Public Works Director recommends that the City accept the Project as complete, thereby authorizing the issuance of the formal notice of completion and release of the labor and performance bonds in the amount of \$388,250.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad adopt the attached Resolution accepting the Well No. 11 Pump Station Project completed by Monterey Peninsula Engineering, Inc., authorizing the release of the labor and performance bonds and 10% retention in the amount of \$39,618.60 and appropriating \$39,618.60 from the Water Fund Well Construction Line Item.


