

RESOLUTION NO. 3958

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROPRIATING \$31,000.00 OF THE TRANSPORTATION CONGESTION RELIEF
(TCR) FUND TO THE SOLEDAD 2005/2006 SIDEWALK AND CURB/GUTTER
REPAIR PROJECT AND RATIFYING THE PREVIOUS APPROPRIATION OF
\$127,735.06 OF TCR FUNDS FOR THE SOLEDAD 2005/2006 SIDEWALK AND
CURB/GUTTER REPAIR PROJECT**

WHEREAS, on November 15, 2006 the City Council approved the construction of the Soledad 2005/2006 Sidewalk and Curb/Gutter Repair Project with a budget of \$680,081 and funding for the project comprised of \$200,000 in Regional Surface Transportation Program and \$480,081 from LTF; and

WHEREAS, the TCR fund can be utilized for the curb gutter sidewalk work currently under construction; and

WHEREAS, on February 7, 2007 the Council appropriated \$127,735.06 of the Transportation Congestion Relief (TCR) Fund to the Soledad 2005/2006 Sidewalk and Curb/Gutter Repair Project and reduced the Local Transportation Fund (LTF) Soledad 2005/2006 Sidewalk and Curb/Gutter Repair Project Appropriation by \$100,000; and

WHEREAS, due to a mistake in both the staff report and the resolution concerning the appropriation, Resolution No. 3938, there is now some concern that the amount of funds appropriated, \$127,735.06, may have been confused with the lesser sum of \$122,735.06 that was also referenced in said staff report and resolution; and

WHEREAS, the Council desires to create a record of the fact that it meant to appropriate \$127,735.06 by ratifying its previous action; and

WHEREAS, in addition to the previously appropriated sum of \$127,735.06, the Council desires to appropriate an additional \$31,000 of TCR Funds as a result of pending changes orders for added work on Inca and Vosti Streets and to fund replacement trees, for a total sum of \$158,735.06 in TCR Funds to be used for the Soledad 2005/2006 Sidewalk and Curb/Gutter Repair Project.

NOW THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad that the Council ratifies all actions taken by its previous adoption of Resolution No. 3938, including but not limited to the appropriation of \$127,735.06 in Transportation Congestion Relief (TCR) funds.

BE IT FURTHER RESOLVED, that the Council appropriates an additional \$31,000.00 of TCR Funds to the Soledad 2005/2006 Sidewalk and Curb/Gutter Repair.


