

**RESOLUTION NO. 3962**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING A TEMPORARY USE PERMIT FOR THE CLOSURE  
OF VARIOUS STREETS AND THE USE OF VOSTI PARK FOR AN EVENT BY OUR  
LADY OF SOLITUDE CATHOLIC CHURCH ON APRIL 6, 2007**

**WHEREAS**, the City Council has considered the Special Event Permit (No. 2007-02) submitted by Our Lady of Solitude Catholic Church requesting permission to hold a one-day "Stations of the Cross" event; and

**WHEREAS**, the Special Event will be conducted in accordance with regulations adopted by the City of Soledad and issued a temporary use permit with specific conditions of approval; and

**WHEREAS**, barricades will be placed at the various intersections on Friday, April 6, 2007 for street closure between the hours of 5:30 p.m. and 7:30 p.m.; and

**WHEREAS**, the costs associated with this event include assistance from Public Works employees for traffic control (\$131.60) and costs associated with use of the lights for two hours at Vosti Park (\$26), all of which must be paid by the Church.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad as follows:

1. **FINDING:** The temporary use of public streets and use of Vosti Park is considered a suitable location for the event and no negative community impacts are expected from the event.

**EVIDENCE:** The event has been reviewed by City staff, including the Police and Fire Departments, and conditions of approval have been attached as Exhibit "A" to assure a safe event. The event, in a modified form, has occurred yearly for the last several years without incident.

2. **FINDING:** In approving the temporary use permit for Our Lady of Solitude Catholic Church, the City Council finds that the proposed use will not, under these particular circumstances, be detrimental to the health, safety, morals, comfort or general welfare of the people residing or working in the neighborhood of this project, or to the general welfare of the City.

**EVIDENCE:** Parking on the surrounding streets will not be impacted because the procession of people would only temporarily be on each street. Additionally, police on duty will monitor the event and police reserves will provide assistance with temporary street closures. As was previously noted, the event has occurred in modified form yearly for the last several years without any negative impact on the community.



**"EXHIBIT A"**

**CONDITIONS OF APPROVAL FOR  
TEMPORARY USE PERMIT  
FOR THE STATIONS OF THE CROSS SPECIAL EVENT  
HELD BY OUR LADY OF SOLITUDE CATHOLIC CHURCH  
April 6, 2007**

1. The procession of the Stations of the Cross shall follow the map provided by the Church between the hours of 5:30 pm – 7:30 pm.
2. The applicant shall advise the surrounding residents along the procession route of the date and time of the special event. Posters, or US Postage mailings, shall be delivered to each residential unit.
3. The applicant shall return any City barricades to the Public Works Department should City barricades be made available for the special event.
4. The applicant shall be responsible for all necessary street clean up.
5. The applicant shall provide the City with proof of insurance, in an amount deemed suitable to the City Manager and City Attorney, naming the City, its elected and appointed officers and officials, employees and agents as additional insured.
6. The applicant agrees to indemnify and hold the City, its elected and appointed officers and officials, employees and agents harmless from any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, in law or equity, of every nature and kind whatsoever arising out of the use of the City's property for the purpose described herein, except for liability arising out of the concurrent or sole negligence of the City, its officers, officials, employees, and agents.

This Temporary Use Permit is hereby accepted upon the express terms and conditions herein, and shall have no force or effect unless and until agreed to, in writing, by applicant and property owner(s). The undersigned hereby acknowledge the approved terms and conditions and agrees to conform to and comply with said terms and conditions of approval of the temporary use permit.
