

RESOLUTION NO. 3985

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROVING A TEMPORARY USE PERMIT FOR THE CLOSURE OF WALKER
DRIVE BETWEEN METZ ROAD AND GRANADA STREET FOR A SPORTS FAIR
EVENT BY THE SOLEDAD RECREATION DISTRICT FROM 3 PM TO 5 PM ON
WEDNESDAY MAY 30, 2007**

WHEREAS, the City Council has considered the Special Event Permit (**No. 2007-01**) submitted by the Soledad Recreation District requesting permission to hold a one-day "Sports Fair" event; and

WHEREAS, the Special Event will be conducted in accordance with regulations adopted by the City of Soledad and issued a temporary use permit with specific conditions of approval, as set forth in Exhibit "A," attached hereto; and

WHEREAS, the costs associated with this event include assistance from Public Works employees for barricades which must be paid by the Recreation District.

NOW THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad as follows:

1. **FINDING:** The temporary closure of Walker Drive is considered a suitable action for the event and no negative community impacts are expected from the event.
2. **FINDING:** In approving a temporary use permit for the Soledad Recreation Department, the City Council finds that the proposed use will not, under these particular circumstances, be detrimental to the health, safety, morals, comfort or general welfare of the people residing or working in the neighborhood of this project, or to the general welfare of the City.
3. Based on the foregoing "findings" the City Council hereby approves the issuance of a temporary use permit, in accordance with the terms and conditions set forth in Exhibit "A," attached hereto and by this reference incorporated herein, for the Soledad Recreation District's Sports Fair



"EXHIBIT A"

**CONDITIONS OF APPROVAL FOR
TEMPORARY USE PERMIT
FOR THE SOLEDAD RECREATION DISTRICT SPORTS FAIR EVENT
ON MAY 30, 2007**

1. The Sports Fair event shall follow the plan provided by the District between the hours of 3 pm – 5 pm.
2. The applicant shall advise the surrounding residents around the event of the date and time of the special event. Posters, or US Postage mailings, shall be delivered to each residential unit.
3. The applicant shall return any City barricades to the Public Works Department should City barricades be made available for the special event.
4. The applicant shall be responsible for all necessary street clean up.
5. The applicant shall provide the City with proof of insurance, in an amount deemed suitable to the City Manager and City Attorney, naming the City, its elected and appointed officers and officials, employees and agents as additional insureds.
6. The applicant agrees to indemnify and hold the City, its elected and appointed officers and officials, employees and agents harmless from any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, in law or equity, of every nature and kind whatsoever arising out of the use of the City's property for the purpose described herein, except for liability arising out of the concurrent or sole negligence of the City, its officers, officials, employees, and agents.
7. Applicant agrees to be responsible for all cost to City associated with providing assistance for the identified event, including, but not limited to, all costs associated with the provision of barricades to be used in blocking streets.

This Temporary Use Permit is hereby accepted upon the express terms and conditions herein, and shall have no force or effect unless and until agreed to, in writing, by applicant and property owner(s). The undersigned hereby acknowledge the approved terms and conditions and agrees to conform to and comply with said terms and conditions of approval of the temporary use permit.
