

**RESOLUTION NO. 4061**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
AUTHORIZING THE CLOSURE OF FRONT STREET TO VEHICULAR TRAFFIC  
BETWEEN KIDDER AND BENITO STREETS ON AUGUST 25, 2007,  
FROM 6AM TO 8PM FOR THE OLDTOWN SOLEDAD BEAUTIFICATION  
ASSOCIATION'S "WIND AND WINE FESTIVAL",  
APPROVAL OF THE USE OF CITY PROPERTY  
AND PROVIDING IN-KIND SUPPORT SERVICES  
AT AN ESTIMATED COST OF \$3,075.00**

**WHEREAS**, the City has received a request from the Oldtown Soledad Beautification Association for closure of Front Street, between Kidder and Benito Streets, and the use of City property on the west side of Front Street, on August 25, 2007 from 6 AM to 8 PM; and

**WHEREAS**, the Oldtown Soledad Beautification Association ("OSBA") is conducting its annual Wind and Wine Festival in the City of Soledad; and

**WHEREAS**, it is Staff and the Council's opinion that the closure of the street will not cause a hardship to local businesses and residents and will be monitored by City of Soledad Police Officers throughout the day; and

**WHEREAS**, the event organizers will be responsible for set-up and clean-up of the public areas used and will provide the City with appropriate insurance certificates; and

**WHEREAS**, proceeds of the event will be used by the OSBA to continue in its efforts to assist local businesses in a variety of areas, including marketing and structure improvement; and

**WHEREAS**, the OSBA has requested that the City provide in-kind services for the event for Police, Fire and support services, at an estimated cost of \$3,075.00.

**NOW, THEREFORE, BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad as follows:

1. All of the recitals set forth above are true and correct to the best of its knowledge, and by this reference are adopted and incorporated herein.
2. That the City Council approves the closure of Front Street as shown on the Map attached hereto as Exhibit "A," for OSBA's 2007 Wind and Wine Festival, located on City Property, and to be held on Saturday, August 25, 2007, subject to Standard Conditions of Approval for a Temporary Use Permit. The City Council also approves the use of City personnel as an in-kind contribution for this event. In addition, prior to set up of the event, OSBA shall be required to provide an insurance policy in a form acceptable to the City, naming the City, its elected and appointed officials, employees and agents as additional insureds.


