

RESOLUTION NO. 4079

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD APPROVING THE PURCHASE OF TWO (2) FULLY-EQUIPPED PATROL VEHICLES AND TWO (2) FULLY-EQUIPPED ADMINISTRATIVE VEHICLES, NOT TO EXCEED \$120,000, FUNDED FROM THE VEHICLE FUND, GENERAL FUND, AND POLICE IMPACT FEE FUND, UTILIZING THE CITY'S IN-LIEU PURCHASE EXCEPTION

WHEREAS, in past years, the City has developed and implemented a policy to accommodate the inevitable deterioration of its fleet of police vehicles whereby it has replaced at least one police vehicle during each fiscal year; and

WHEREAS, the City has the need to add two (2) Police Department Administrative vehicles, and replace two (2) patrol vehicles, unit #50, a 2001 Ford Crown Victoria with over 90,000 miles, and unit #54, a 2000 Ford Crown Victoria with over 88,000 miles; and

WHEREAS, the City's In-Lieu Purchase Exception, adopted pursuant to Ordinance No. 597, allows the City to dispense with its formal bidding procedures for purchasing equipment through the use of bidding procedures used by other municipalities or public entities; and

WHEREAS, the City has obtained information and copies of documents used by the County of Los Angeles indicating that said entity purchased two (2) 2008 Ford Crown Victoria Police Interceptors patrol vehicles from Wondries Fleet Division ("Wondries") in Alhambra, California, the lowest responsible bidder in a competitive bidding process (County of Los Angeles Bid #311103045) on a bid awarded on May 1, 2007, at a total price of \$64,079.28 (including equipment cost and applicable sales tax); and

WHEREAS, the City has obtained information and copies of documents used by the County of Los Angeles indicating that said entity purchased four (4) 2008 Ford Crown Victoria Police Interceptors from Wondries Fleet Division ("Wondries") in Alhambra, California, the lowest responsible bidder in a competitive bidding process (County of Los Angeles Bid #311103045) on a bid awarded on May 1, 2007, at a total price of \$54,365.98 (including equipment cost and applicable sales tax); and

WHEREAS, Staff has confirmed that Wondries provides vehicles for police agencies throughout the State of California, including the Santa Cruz County Sheriff's Department and the Watsonville, Seaside, Monterey, Del Rey Oaks and Gonzales Police Departments; and

WHEREAS, City desires to purchase four (4) 2007 Ford Crown Victoria Police Interceptors from Wondries, for a total price, including applicable 7.25% sales tax and \$8.75 Tire tax, in an amount not to exceed \$120,000.00; and

WHEREAS, the City Council authorizes the expenditure of \$54,365.98 designated in the Police Impact Fees Fund for police equipment; and

WHEREAS, the City Council authorizes the expenditure of \$63,450.00 designated in the Vehicle Fund for patrol vehicle replacement; and

WHEREAS, the City Council authorizes a budget appropriation not to exceed \$629.28 from the General Fund Reserves; and

WHEREAS, in accordance with the City of Soledad In-Lieu Purchase Exception, the City Manager and/or Staff have determined: 1) that the use of said exception for the proposed purchase of four (4) 2008 Ford Crown Victoria Police Interceptors is appropriate; 2) that the bid for the purchase of such vehicles received by the County of Los Angeles was made within the preceding twelve months; 3) that there has been no significant change in the price of the requested equipment since the time the County of Los Angeles bid was awarded to Wondries Fleet Division; 4) that regional variations in vendor sites will not have a significant impact on the identified purchase price, and 5) that Wondries Fleet Division provided the lowest responsible bid or equivalent thereto to the County of Los Angeles for the purchase of police vehicles.

NOW THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad as follows:

1. All of the recitals set forth above are true and correct to the best of its knowledge, and are incorporated herein.
2. That the City Manager is hereby authorized to purchase four (4) 2008 Ford Crown Victoria Police Interceptors for a cost not to exceed \$120,000 from Wondries Fleet Division.




