

RESOLUTION NO. 4111

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROVING A TEMPORARY USE PERMIT AND AUTHORIZING SPONSORSHIP
OF THE ANNUAL SOLEDAD-MISSION CHAMBER OF COMMERCE CHRISTMAS
PARADE AND FESTIVITIES AND AUTHORIZING THE PROVISION OF IN-KIND
SUPPORT SERVICES FROM PUBLIC WORKS, POLICE AND FIRE DEPARTMENT
AT AN ESTIMATED COST OF \$3,031**

WHEREAS, the Soledad-Mission Chamber of Commerce (“Chamber”) is a community based organization establishing as one of its goals, a time of celebration, enjoyment and friendship for all the citizens of Soledad; and

WHEREAS, the Chamber is a recognized non-profit charitable organization; and

WHEREAS, through its activities, the Chamber provides and works diligently for the betterment of the community and to enrich the quality of life for citizens of Soledad; and

WHEREAS, the Chamber sponsors an “Annual Christmas Parade and Festivities” along with other fund raising events; and

WHEREAS, the Chamber has planned and submitted an application for a Temporary Use Permit to hold its “Annual Christmas Parade and Festivities” on Saturday, December 1, 2007, and requests the City to act as co-sponsor for the event and to provide in-kind support services similar to support provided in past years.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Soledad approves the Temporary Use Permit for the Soledad-Mission Chamber of Commerce 2007 Annual Christmas Parade and Festivities, authorizes Chamber of Commerce use of Caesar Chavez Park and the property currently leased by the City (APN 022-211-017) for aforesaid festivities, and further authorizes the City Manager to direct staff to provide reasonable assistance and support for said event in an amount up to but not exceeding \$3,031, provided that such assistance is fully consistent with City policies, rules and regulations and does not require the expenditure of unbudgeted City funds. Any request contrary to City policies, rules and regulations, or requiring expenditure of City funds will be brought before the City Council for due consideration.


