

**RESOLUTION NO. 4123**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
HONORING ASSEMBLYMEMBER ANNA M. CABALLERO  
FOR HER CONTINUED ASSISTANCE  
TO THE PEOPLE OF THE CITY OF SOLEDAD**

**WHEREAS**, Assemblymember Anna M. Caballero, "hereinafter Anna," has been a strong advocate for public safety, affordable housing, quality health care and education; and

**WHEREAS**, Anna moved from a successful law business to the field of public service, was elected to the City Council of the City of Salinas in 1991 and was elected Mayor of the City of Salinas in 1998; and

**WHEREAS**, Anna was elected to serve the 28<sup>th</sup> Assembly District in November of 2006; and

**WHEREAS**, the City of Soledad's existing wastewater treatment facilities are inadequate to continue to treat and dispose of, in accordance with regional water quality board requirements, the current volume of wastewater now being generated and do not meet the City's need for increased capacity; and

**WHEREAS**, Anna took an active interest and assisted the City of Soledad by sponsoring Assembly Bill 1253 to allow the State to lease/sell/convey or exchange, at fair market value, the wastewater treatment plant at the Correctional Training Facility in Soledad to the City of Soledad in order for the City to expand its wastewater treatment facilities to the benefit of the citizens of the City of Soledad; and


**WHEREAS**, after the failure of Senate Bill 455, Anna was successful in getting Assembly Bill 1253 through the legislative process in record time and subsequently was successful in getting Assembly Bill 1253 approved and signed by Governor Schwarzenegger on October 14, 2007.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SOLEDAD DOES HEREBY RESOLVE** that the Mayor and City Council, on behalf of the Soledad community, hereby honor ANNA M. CABALLERO for her dedication, her humanitarian services and steadfast work for the City of Soledad and extend their sincere appreciation to Anna, her family and her professional team.


