

**RESOLUTION NO. 4178**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING A PLAN FOR USING  
PROPOSITION 1B LOCAL STREETS & ROAD FUNDS**

**WHEREAS**, Proposition 1B (Prop 1B) provided \$19.925 billion in bond funds for a variety of transportation priorities, including \$2 billion for cities and counties to fund the maintenance and improvement of local transportation facilities; and

**WHEREAS**, the 2007 Budget Act and Chapter 181, Statutes of 2007 (SB 88), appropriate a total of \$950 million of the Prop 1B funds in 2007-08 and of this amount, Chapter 314, Statutes of 2007 (AB 196), specifies that \$550 million be allocated to cities; and

**WHEREAS**, each city council must approve a plan for use of the amount of funds available in 2007-08 for the city as determined by the State Controller's Office to receive the funds; and

**WHEREAS**, for Fiscal Year 2007-08, \$456,167.38 is available for the City of Soledad from Prop 1B fund; and

**WHEREAS**, Staff has reviewed the adopted Pavement Management System; and

**WHEREAS**, local streets require regular maintenance to extend their useful lives.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad as follows:

Section 1. The City Council approves a plan to allocate the entire Prop 1B Local Streets and Roads Funds to perform the maintenance of local streets. The maintenance program includes pavement repairs such as pothole filling/crack filling/minor pavement patching, slurry sealing, and resurfacing, including full or partial reconstruction, to various City streets such as Front Street, West Street, Gabilan Drive, Monterey Street, Andalucía Street, and Walker Street.

Section 2. The City Manager or her designee is directed to submit the plan to California Department of Finance for review and approval.

Section 3. The City Manager or her designee is directed to perform the maintenance program on local streets after approval by the California Department of Finance in accordance with State and City requirements and procedures.


