**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
CERTIFYING LOCAL APPROVAL FOR HOUSING ADVOCACY COUNCIL OF
MONTEREY COUNTY PERTAINING TO FEDERAL EMERGENCY SHELTER
GRANT FUNDING TO ASSIST ELIGIBLE FAMILIES IN THE CITY OF SOLEDAD**

WHEREAS, the Housing Advocacy of Monterey County is submitting a proposal for funding authorized by the Federal Homeless Housing Act through the State of California Department of Housing & Community Development; and

WHEREAS, the Housing Advocacy of Monterey County is requesting the City of Soledad, which has participated in the Federal Emergency Shelter Grant program under the auspices of the Housing Advocacy of Monterey County since 1996, to certify their approval of Housing Advocacy of Monterey County's efforts to provide rental assistance to Soledad families for rental housing and to avoid eviction; and

WHEREAS, the Housing Advocacy of Monterey Council is required to file a Certification of Local Approval from each City jurisdiction where they provide assistance as part of their application with and for Federal Emergency Shelter Grant funding (FESG).

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council of the City of Soledad hereby approves the City's continued participation in the Housing Advocacy of Monterey County Emergency Shelter Program ("Exhibit "A").



CERTIFICATION OF LOCAL APPROVAL

Instructions: If the Project is located in an FESG-eligible city, the Certification of Local Approval must be completed by the city.

If the Project is located in the unincorporated area of an FESG-eligible county, the Certification must be from the county.

Organizations may apply for multiple shelters and Projects located in more than one eligible city or county. However in this case, the Certification of Local Approval is required for each city or county, as applicable.
