

RESOLUTION NO. 4263

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AUTHORIZING THE CLOSURE OF MAIN STREET TO VEHICULAR TRAFFIC
BETWEEN MONTEREY AND MARKET STREETS ON AUGUST 10, 2008,
FROM 10 A.M. TO 7 P.M., FOR OUR LADY OF SOLITUDE CATHOLIC CHURCH
ANNUAL FIESTA AND THE APPROVAL OF THE USE OF
CITY PROPERTY FOR FIESTA ACTIVITIES**

WHEREAS, the City has received a request from Our Lady of Solitude Catholic Church for closure of Main Street, between Monterey and Market Streets, and the use of City property adjacent to or in close proximity to Main Street, on August 10, 2008 from 10 a.m. to 7 p.m.; and

WHEREAS, Our Lady of Solitude Church has conducted similar annual Fiestas in a manner and location as described herein, with approval of the City of Soledad; and

WHEREAS, the closure of the street will not cause a hardship to the local neighborhood and residents, and will be monitored by City of Soledad Police Officers throughout the day; and

WHEREAS, the event organizers will be responsible for set-up and clean-up of the public areas used and will provide the City with appropriate insurance certificates.

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the City Council of the City of Soledad:

1. That the City Council approves the closure of Main Street, between Monterey and Market Streets, and the use of City property, all as shown on the Map attached hereto as Exhibit "A," as an accommodation to the 2008 Annual Fiesta of Our Lady of Solitude Church to be held on Sunday, August 10, 2008, subject to Standard Conditions of Approval for a Temporary Use.
2. That, prior to set-up of the event, Our Lady of Solitude Church shall be required to provide an insurance certificate in a form acceptable to the City, naming the City, its elected and appointed officials, employees and agents as additional insureds.
3. That, prior to approval of the Temporary Use Permit, that Our Lady of Solitude Church shall be required to provide a refundable security deposit of \$150.00 which shall be returned provided that all litter and refuse from the event on the City Hall site and closed section of Main Street have been adequately cleaned to the satisfaction of the Public Works Director.


