

RESOLUTION NO. 4278

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AUTHORIZING THE CLOSURE OF VARIOUS SECTIONS OF STREETS ALONG A
5K RACE ROUTE AND OF THE SECTION OF FRONT STREET BETWEEN KIDDER
AND BENITO STREETS TO VEHICULAR TRAFFIC
ON SUNDAY, SEPTEMBER 28, 2008,
FOR THE OLDTOWN SOLEDAD BEAUTIFICATION ASSOCIATION'S
"FIFTH ANNUAL WIND & WINE FESTIVAL AND 5K RUN;"
APPROVING THE USE OF CITY PROPERTY;
AND PROVIDING IN-KIND SUPPORT SERVICES**

WHEREAS, the City has received a request from the Oldtown Soledad Beautification Association for closure of Front Street, between Kidder and Benito Streets, and the use of City property on the west side of Front Street, on Sunday, September 28, 2008, from 6:00 a.m. to 8:00 p.m.; and

WHEREAS, the Oldtown Soledad Beautification Association ("OSBA") is conducting its Fifth Annual Wind & Wine Festival and 5K Run in the City of Soledad; and

WHEREAS, both Staff and the City Council have concluded that the race and festival events and closure of Front Street will not cause a hardship to local businesses and residents and will be monitored by City of Soledad Police Officers throughout the day; and

WHEREAS, the 5K Race event organizers will be responsible for full organization and management of the race event in a manner that ensures adequate safety for participants and allows for access for residents along the race route; and

WHEREAS, the Wind and Wine Festival organizers will also be responsible for set-up and removal of event equipment and facilities and clean-up of the public areas used, and, further, will provide the City with appropriate insurance coverage certificates; and

WHEREAS, proceeds of the event will be used by the OSBA to continue in its efforts to assist local businesses in a variety of areas, including marketing and structure improvement; and

WHEREAS, the OSBA has requested that the City provide in-kind services for the event for Public Works, Police and Fire and support services, at an estimated cost of \$3,478.00; and

WHEREAS, the City will serve as a co-sponsor of the event for providing in-kind services.

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the City Council of the City of Soledad as follows:

1. All of the recitals set forth above are true and correct to the best of its knowledge, and by this reference are adopted and incorporated herein.

2. That the City Council approves the closure of affected streets—as indicated on the race route map attached hereto as Exhibit “A”— as needed during the time of the actual race event between the hours of 8:30 a.m. and 10:30 a.m. on September 28, 2008.
3. That the City Council further approves the closure of Front Street between the hours of 6 a.m. and 8 p.m. on September 28, 2008, as shown on the Map attached hereto as Exhibit “B,” for OSBA's 2008 Wind & Wine Festival and 5K Run, located on City Property, and to be held on Sunday, September 28, 2008, subject to Standard Conditions of Approval for a Temporary Use Permit. The City Council also approves the use of City personnel as an in-kind contribution for this event. In addition, prior to set up of the event, OSBA shall be required to provide an insurance policy in a form acceptable to the City, naming the City, its elected and appointed officials, employees and agents as additional insureds.
4. That the City Council authorizes the use of City-owned property.
5. That the City Council authorize the use of City-leased property on Front Street for public use in accordance with provisions established by the Lease Agreement entered by and between Modesto Gutierrez and City of Soledad.
6. That the aforesaid approvals are contingent upon provision of a letter of support from the Soledad-Mission Chamber of Commerce attached hereto as Exhibit “C”.





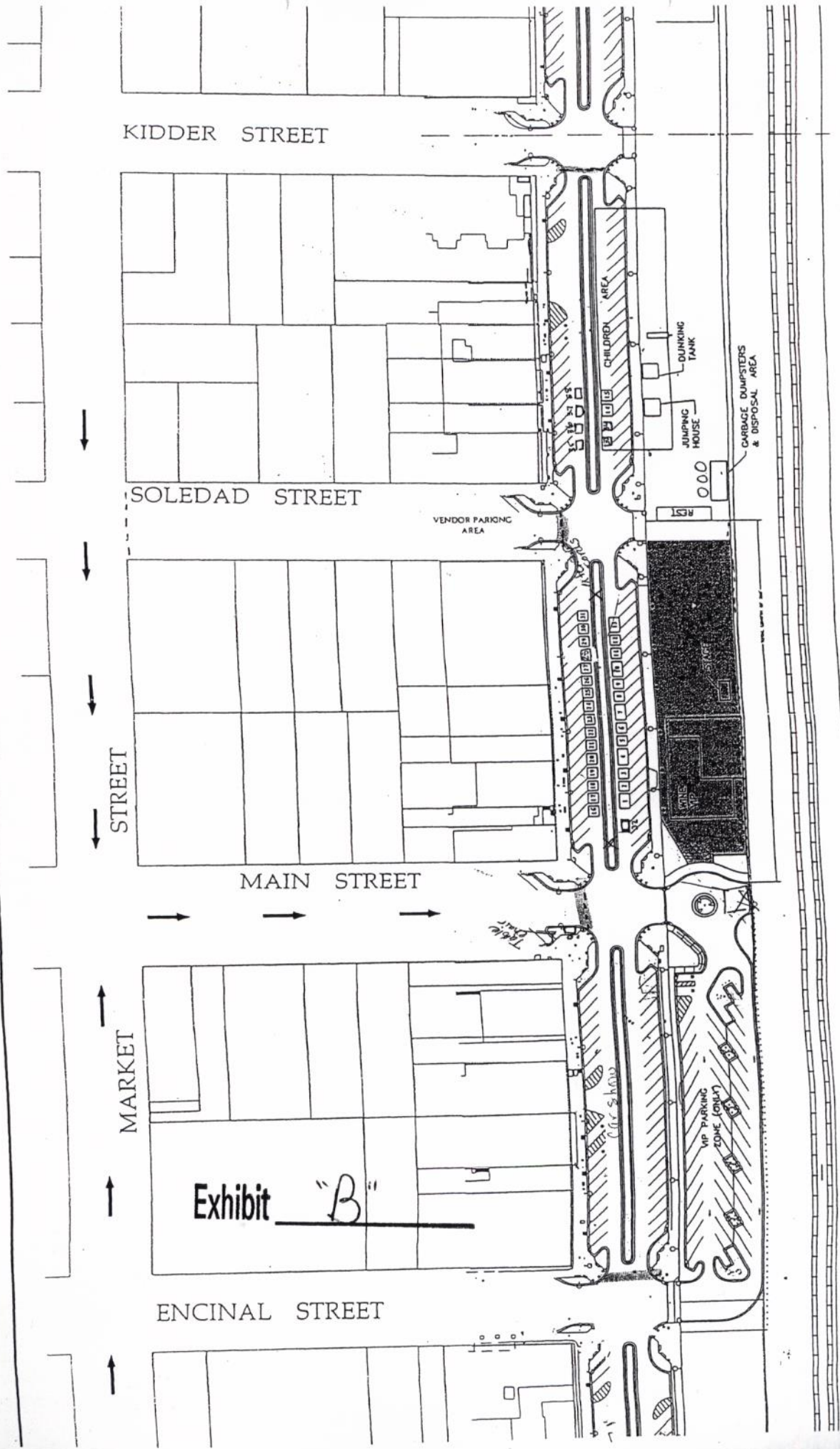
