

RESOLUTION NO. 4353

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING A TEMPORARY USE PERMIT FOR THE CLOSURE  
OF MONTEREY STREET AND USE OF VOSTI PARK FOR AN EVENT BY  
"OUR LADY OF SOLITUDE CATHOLIC CHURCH" ON APRIL 10, 2009**

**WHEREAS**, the City Council has considered the Special Event Permit (No. 2009-06) submitted by Our Lady of Solitude Catholic Church requesting permission for street closure and use of Vosti Park; and

**WHEREAS**, the Special Event will be conducted in accordance with regulations adopted by the City of Soledad and specific conditions of approval for the requested temporary use permit; and

**WHEREAS**, barricades will be placed at various intersections along Monterey Street by the applicant's volunteers on Friday, April 10, 2009, for street closure between the hours of 5:30 p.m. and 7:30 p.m.; and

**WHEREAS**, the costs associated with this event if any, will be paid by the church.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad finds as follows:

1. The temporary use of public streets and use of Vosti Park is considered a suitable location for the event and no negative community impacts are expected from the event.
2. In approving the temporary use permit for Our Lady of Solitude Catholic Church, the City Council finds that the proposed use will not, under these particular circumstances, be detrimental to the health, safety, morals, comfort or general welfare of the people residing or working in the neighborhood of this project, or to the general welfare of the City.



**CONDITIONS OF APPROVAL FOR  
TEMPORARY USE PERMIT  
FOR THE STATIONS OF THE CROSS SPECIAL EVENT  
HELD BY OUR LADY OF SOLITUDE CATHOLIC CHURCH  
April 10, 2009**

1. The procession of the “Stations of the Cross Good Friday” event shall follow the map provided by the Church between the hours of 5:30 p.m. – 7:30 p.m.
2. The applicant shall advise the surrounding residents along the procession route of the date and time of the special event. Notification shall be delivered to each residential unit along the route, including the City of Soledad.
3. The applicant shall erect and remove all City of Soledad barricades made available for the special event and return to the Public Works Department – City Yard.
4. The applicant shall assume responsibility to repair and/or replace lost, damaged or stolen City of Soledad property attributed to the special event.
5. The applicant shall be responsible for all necessary street clean up.
6. The applicant shall provide the City with proof of insurance, in an amount deemed suitable to the City Manager and City Attorney, naming the City, its elected and appointed officers and officials, employees and agents as additional insured.
7. The applicant agrees to indemnify and hold the City, its elected and appointed officers and officials, employees and agents harmless from any and all claims, demands, causes of action, damages, costs, expenses, losses or liabilities, in law or equity, of every nature and kind whatsoever arising out of the use of the City’s property for the purpose described herein, except for liability arising out of the concurrent or sole negligence of the City, its officers, officials, employees, and agents.

This Temporary Use Permit is hereby accepted upon the express terms and conditions herein, and shall have no force or effect unless and until agreed to, in writing, by applicant and property owner(s). The undersigned hereby acknowledge the approved terms and conditions and agrees to conform to and comply with said terms and conditions of approval of the temporary use permit.
