**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION FOR 2009-10
GENERAL/NATIVE AMERICAN ALLOCATION OF THE STATE COMMUNITY
DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FOR A STREET LIGHT
IMPROVEMENT PROJECT FOR A MAXIMUM AMOUNT NOT TO EXCEED
\$800,000 AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO TAKE ALL
ACTIONS NECESSARY FOR THE COMPLETION AND SUBMISSION OF SAID
GRANT APPLICATION AND ANY AND ALL AMENDMENTS, AGREEMENTS AND
DOCUMENTS THERETO**

WHEREAS, the State Department of Housing and Community Development has issued a Notice of Funding for the FY 2009/10; and

WHEREAS, the City desires to submit an application for the General/Native American Allocation of the State Community Development Block Grant(CDBG) Program in an amount not to exceed \$ 800,000 to fund a Street Light Improvement Project; and

WHEREAS, this project will cover an area of approximately 16 blocks, which currently has insufficient street lighting, creating multiple problems, including; vehicular traffic and pedestrian safety consideration and conflicts and heightened incidences of crime; and

WHEREAS, the City Council held a public hearing on July 1, 2009 to hear this matter; and

WHEREAS, Staff is recommending that the City Council approve a resolution to submit a formal application for the General/Native American Allocation of the State Community Development Block Grant (CDBG) to fund a Street Light Improvement Project

NOW THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad that the City Council approves the submission of an application General/Native American Allocation of the State Community Development Block Grant (CDBG) Program to fund a Street Light Improvement Project, in an amount not to exceed \$800,000. The City Manager, or her designee thereof, is hereby authorized and directed to take all actions necessary for the completion and submission of said grant application, and any and all amendments, agreements and documents thereto.




