

**RESOLUTION NO. 4415/370**

**A JOINT RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD AND THE BOARD OF DIRECTORS OF THE REDEVELOPMENT AGENCY OF THE CITY OF SOLEDAD AUTHORIZING THE CITY MANAGER/EXECUTIVE DIRECTOR TO EXECUTE A STANDARD SERVICE AGREEMENT WITH CIVIC PLUS FOR WEBSITE DESIGN AND IMPLEMENTATION SERVICES AND AUTHORIZE BUDGET AMENDMENT IN THE AMOUNT OF \$27,750**

**WHEREAS**, Staff is of the opinion that the City's current website does not meet the needs of the City; and

**WHEREAS**, based on the recommendation of the City's IT Committee, the City of Soledad issued an RFP for website design and received RFP's proposals from ten companies; and

**WHEREAS**, the ten proposals were reviewed by Staff and the IT Committee and after evaluating the firms on the basis of experience, customer support, cost, stability, quality of service and content of the proposal, it has been determined that Civic Plus firm is best suited to meet the City's needs; and

**WHEREAS**, the Redevelopment Agency will use the website to advertise the enterprise zone, marketing of available property, housing monitoring and as required by AB987 advertising of programs for business and housing loans; and

**WHEREAS**, in the Fiscal Year 2009-2010 budget, the City did not appropriate funds for Website design Services. The funds will be allocated as follows: \$5,716.66 general fund, \$14,981.67 Enterprise and \$7,051.67 from RDA, Low and Mod; and

**NOW THEREFORE, BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad hereby authorizes the City Manager/Executive Director to:

Section 1: Execute a modified Standard Service Contract with Civic Plus in an amount not to exceed \$27,750, in a final form subject to the approval of the City Manager and City Attorney

Section 2: Authorize budget amendment and transfer from the following accounts to Internal Services account (402-5190-3005);

General Fund	\$5,716.66
Enterprise	\$14,981.67
RDA, Low and Mod	\$7,051.67


