

**RESOLUTION NO. 5041**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD APPROVING A "LICENSE AGREEMENT FOR JOINT USE OF PARKING FACILITIES BY AND BETWEEN THE SOLEDAD UNIFIED SCHOOL DISTRICT AND THE CITY OF SOLEDAD", AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF SOLEDAD**

**WHEREAS**, Soledad Unified School District (SUSD) has asked the City to consider a joint use agreement for the SUSD's Gabilan School parking lot and the City's Community Center parking lot; and

**WHEREAS**, there are times when SUSD events require more parking than their lot will accommodate and there are times when Community Center events require more parking than that facility's parking lot can accommodate; and

**WHEREAS**, the Agreement will be at no cost to each party, with City and District each bearing their own costs, and will have an initial term of one year, subject to termination by either party with or without cause.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad that the "License Agreement for Joint Use of Parking Facilities By and Between the Soledad Unified School District and the City of Soledad" between the City of Soledad and Soledad Unified School District, a copy of which is attached hereto as Exhibit "A" and by this reference incorporated herein, is hereby approved and the City Manager is authorized and directed to execute the same on behalf of the City.


