**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING AN AMENDMENT TO THE CONSULTING SERVICES AGREEMENT  
WITH FORD & BONILLA, LLC FOR PUBLIC INFORMATION OFFICER AND  
SOCIAL MEDIA SERVICES**

**WHEREAS**, in February 2013, the City Manager entered into an Agreement with Ford & Bonilla, LLC to provide Public Information Officer and Social Media services; and

**WHEREAS**, Ford & Bonilla, LLC will provide Public Information Officer and Social Media services until June 30, 2015 at a reduced rate from \$5,000 per month to \$2,650 per month.

**NOW, THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Soledad that the Amendment to the Contract titled "Consulting Services Agreement Between the City of Soledad and Ford & Bonilla, LLC," a copy of which is attached hereto as "Exhibit A," and by reference incorporated herein, for a reduction in compensation from \$5,000 per month to \$2,650 per month is hereby approved in substantial form and content, subject to final approval by the City Manager and the City Attorney, and the City Manager is authorized and directed to execute the same on behalf of the City of Soledad.



**CONTRACT AMENDMENT NUMBER 2  
TO THE CONTRACT TITLED:**

**CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SOLEDAD AND  
FORD & BONILLA, LLC**

On June 5, 2013, the City Council of the City of Soledad awarded a Consulting Services Agreement to Ford & Bonilla, LLC (the "Agreement"). The parties hereto now agree that the Agreement is amended as follows:

1. Section-2 Compensation is decreased by \$14,100 for the remaining six months of the contract, thereby decreasing the total cost of the Agreement to a not-to-exceed amount of \$45,900.
2. Scope of Services. The Scope of Services to the original Consulting Services Agreement will remain unchanged.
3. All other terms and conditions of the Agreement shall remain in full force and effect, and shall be applicable to the work described in Attachment A.
