RESOLUTION NO. 5051

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD AND THE SUCCESSOR AGENCY OF THE SOLEDAD REDEVELOPMENT AGENCY ACCEPTING THE 2014-15 MID-YEAR BUDGET UPDATE AND AUTHORIZING AMENDMENTS TO THE CITY OF SOLEDAD BUDGET FOR FISCAL YEAR 2014-15

NOW THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad that the "Fiscal Year 2014-15 Mid-Year Budget Amendments Summary, Exhibit D", a copy of which is attached hereto and by this reference incorporated herein, is hereby approved and the City Manager is hereby authorized and directed to execute the same on behalf of the City.

BE IT FURTHER RESOLVED, that the City Manager of the City of Soledad, or her authorized designee, is hereby authorized to revise all budget documents for Fiscal Year 2014-15 budget as approved in Resolution 5004/SA-2014-05 as necessary.




