

**RESOLUTION NO. 5082**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING THE CONSULTANT LIST TO PROVIDE ON-CALL PLANNING AND  
ENVIRONMENTAL SERVICES FOR ANTICIPATED ENTITLEMENT PROJECTS**

**WHEREAS**, previous cuts were made in the City operating budget including reductions in Community & Economic Development Staff hours as a way to significantly reduce city operational cost; and

**WHEREAS**, part of this cost-savings strategy is to retain on-call contract planning staff for planning entitlement projects that would require significant staff processing time; and

**WHEREAS**, the City submitted a Request for Qualification for such on-call contract services; and

**WHEREAS**, multiple qualified consultants responded and the City seeks to include them on a pre-qualified list for on-call planning projects for a period until June 30, 2017.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the City of Soledad City Council that the On-Call Planning and Environmental Services Consultant List, a copy of which is attached hereto as Exhibit "A" and by reference incorporated herein, is hereby approved and the City Manager is hereby authorized and directed to execute the same on behalf of the City of Soledad.


