

RESOLUTION NO. 5106

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO AN
AGREEMENT BETWEEN THE CITY OF SOLEDAD AND MONTEREY BAY
ANALYTICAL SERVICES, INC. FOR LABORATORY SERVICES IN THE AMOUNT
OF \$62,730.00**

WHEREAS, the City of Soledad is responsible for sample collection, analyses and reporting for regulatory compliance and operational control for the City's Water Reclamation Facility (WRF), water and stormwater utilities; and

WHEREAS, due to laboratory staff member vacancies, the City Manager executed an agreement with Monterey Bay Analytical Services, Inc. (MBAS) to provide Laboratory Services; and

WHEREAS, on July 3, 2013, on April 2, 2014 and January 7, 2015, the City Council authorized agreement amendments with (MBAS) to continue providing Laboratory Services; and

WHEREAS, there is continued essential need for Laboratory Services; and

WHEREAS, it is requested that Council approve this amendment authorizing the City Manager to retain the services of Monterey Bay Analytical Services for additional services; and

NOW THEREFORE, BE IT HEREBY RESOLVED, by the City Council of the City of Soledad that the Council authorize and approve the Execution of an Amendment to the Consulting Services Agreement with MBAS extending Section 1.1 Term, as allowed in section 8.2 to December 15, 2015, and increasing Section 2 Compensation by \$62,730.00 for laboratory services.
