**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROVING CALFIRE SOLEDAD STATION'S REQUEST FOR USE OF THE
SOLEDAD COMMUNITY CENTER ON JANUARY 11, 12, & 13, 2016
FOR THEIR FIRE RELATED TRAINING, AND AUTHORIZING


