**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
APPROVING AN AMENDMENT TO A CONSULTING SERVICES AGREEMENT

WHEREAS, on June 5, 2013 the City Council of the City of Soledad adopted Resolution No. 4861, approving a one year extension with InfoSend, Inc. through June 30, 2014; and

WHEREAS, on May 7th, 2014 the City Council of the City of Soledad adopted Resolution No. 4968, approving a two year extension with InfoSend, Inc. through June 30, 2016; and

WHEREAS, InfoSend, Inc. has delivered good customer service to the City of Soledad, has been extremely responsive to any and all requests for services from the City and to Continue uninterrupted utility billing services; and

WHEREAS, InfoSend, Inc. and the City of Soledad are interested in continuing their partnership for two (2) additional years, through June 30, 2018; and

NOW, THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Soledad that the Amendment to the "Consulting Services Agreement Between the City of Soledad and InfoSend, Inc.," a copy of which is attached hereto as Exhibit A, and by reference incorporated herein, is hereby approved.


