

**RESOLUTION NO. 5270**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD  
APPROVING A CONSULTING SERVICES AGREEMENT AMENDMENT FOR ON-  
CALL ENGINEERING SERVICES WITH HARRIS & ASSOCIATES AND  
AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AMENDMENT ON  
BEHALF OF THE CITY OF SOLEDAD**

**WHEREAS**, on March 6, 2013, the City entered into an agreement with Harris & Associates for on-call water resources engineering services; and

**WHEREAS**, on March 4, 2015, the City extended the agreement with Harris & Associates for engineering services which is set to expire March 7, 2017; and

**WHEREAS**, the contract with Harris & Associates has allowed the City to continue with its various projects; and

**WHEREAS**, the City continues to have a need for supplemental professional engineering services that require a California engineering license; and

**WHEREAS**, an extension of the agreement with Harris & Associates will provide continuity to the projects that are currently being worked on and;

**WHEREAS**, in order to complete those projects, staff recommends a two year extension agreement with Harris & Associates, which would extend the current agreement under the same terms and conditions to March 6, 2019.

**NOW THEREFORE, BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad that the "Consulting Services Agreement Amendment" between the City and Harris & Associates, a copy of which is attached hereto as **Exhibit A** and by reference incorporated herein, is hereby approved and the City Manager is hereby authorized and directed to execute the same on behalf of the City of Soledad.
