

RESOLUTION NO. 5336

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD
AUTHORIZING THE CITY MANAGER TO USE THE CITY'S NO BIDS RECEIVED
PROCEDURE AND EXECUTE A CONTRACT WITH TRUCK SITE FOR THE
PURCHASE OF A 2004 FORD F550 XL SD TEREX HI-RANGER TL 36P BUCKET
TRUCK AT A COST OF \$55,008.94 AND ALLOCATING FUNDING THEREFORE**

WHEREAS, the City of Soledad has one existing 21 year-old bucket truck that is no longer usable; and

WHEREAS, on May 3, 2017, a Notice Inviting Bids was advertised in the Soledad Bee and posted on the City of Soledad website with an advertised bid due date of May 24, 2017 @ 2:00 PM; and

WHEREAS, on May 24, 2017 no bids were received; and

WHEREAS, Soledad Municipal Code Section 3.24.060 G provides: If no bid is received, the City Council, in its discretion, may either:

1. Readvertise; or
2. Direct that the required item or items be purchased without further complying with the provisions of this chapter; and

WHEREAS, after receiving no bids at the May 24, 2017 bid opening, staff searched online and obtained a quote for a used bucket truck; and

WHEREAS, the City received the attached quote for a used Public Works bucket truck from Truck Site in the total amount of \$55,008.94; and

WHEREAS, Staff is recommending that Council approve and authorize the purchase of this vehicle as described in option 2 listed above; and

WHEREAS, one bucket truck was budgeted for in the amount of \$35,000 and a pickup in the amount of \$25,000 (this bucket truck will serve as both) in FY 2016-2017 but no bids were received and no purchase was made; and

WHEREAS, there is adequate fund balance in Wastewater, Gas Tax and Assessment Districts funds for this necessary purchase and staff will bring Budget Amendments to Council for approval after the Mid-year true-up is complete.

BE IT HEREBY RESOLVED, the City Council of the City of Soledad hereby authorizes the purchase of one 2004 Ford Bucket Truck, in the Amount of \$55,008.94 from Truck Site, Authorizing the City Manager to Purchase Said Equipment.
