

**RESOLUTION NO. 5368**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLEDAD APPROVING AN AMENDMENT TO A NON EXCLUSIVE CONSULTING SERVICES AGREEMENT FOR DESIGN SERVICES WITH BELLINGER FOSTER STEINMETZ LANDSCAPE ARCHITECTURE AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF SOLEDAD FOR THE PARKS PLAYGROUND EQUIPMENT UPGRADES AND EXPANSION PROJECT IN THE AMOUNT OF \$32,222**

**WHEREAS**, on October 12, 2016, Council awarded a professional Services Agreement with Bellinger Foster Steinmetz Landscape Architecture (BFS LA) to perform design, formal CA Procurement Code and DIR compliant bidding and construction management services for City Parks projects through October 12, 2018, unless extended or terminated; and

**WHEREAS**, the city has a current need for professional services to design, bid and manage construction of four park upgrades projects; and

**WHEREAS**, staff requested and received proposals from BFS LA to perform all services necessary to complete these projects; and

**WHEREAS**, staff recommends approval of the attached Resolution to award BFS LA all four projects; and

**BE IT HEREBY RESOLVED**, by the City Council of the City of Soledad that the "Amendment to a Non-Exclusive Consulting Services Agreement" between the City of Soledad and Bellinger Foster Steinmetz Landscape Architecture in the Amount of \$32,222, a copy of which is attached hereto as **Exhibit A** and by reference incorporated herein, is hereby approved and the City Manager is hereby authorized and directed to execute the same on behalf of the City of Soledad.




**CONTRACT AMENDMENT NUMBER 1
